HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on July 23, 2020, from Lansing, Michigan. Petitioner, [REDACTED], appeared and represented himself. Respondent, Department of Health and Human Services (Department), had Cynthia Powell, Eligibility Specialist, and Maia Elvine-Fair, Assistance Payments Supervisor, appear as its representatives. Neither party had any additional witnesses.

One exhibit was admitted into evidence during the hearing. A 10-page packet of documents provided by the Department was admitted collectively as the Department's Exhibit A.

ISSUE

Did the Department properly cancel Petitioner's State SSI payment (SSP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was receiving Supplemental Security Income (SSI) and State SSI Payments (SSP).
2. The Department issued Petitioner's SSP payments to him quarterly.
3. In January 2020, the Social Security Administration (SSA) did not make Petitioner's SSI payment at the first of the month.
4. The Department received a report that indicated that Petitioner did not receive a regular first of the month payment in January.

5. On May 18, 2020, the Department issued a Notice of State SSI Payment Change which notified Petitioner that his SSP had been cancelled effective May 18, 2020, because he had not received a regular first of the month SSI payment for three months.
6. On May 28, 2020, Petitioner requested a hearing to dispute the Department's decision.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

SSP payments are only made for the months an individual received a regular first of the month federal benefit (SSI). BEM 660 (January 1, 2017), p. 1-2. A Notice of State SSI Payment Change is issued by the Department when the Department determines that an individual's quarterly SSP will be less than the prior quarter. *Id.* at 3.


In this case, Petitioner had an interruption in his SSI payments in January 2020. The SSA did not issue an SSI payment to Petitioner at the first of the month. When the Department discovered that Petitioner did not receive his SSI payment at the first of the month for three months, the Department stopped Petitioner's SSP payments. The Department's actions were in accordance with BEM 660.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did act in accordance with its policies and the applicable law when it cancelled Petitioner's State SSI payment effective May 18, 2020.

IT IS ORDERED the Department's decision is AFFIRMED.
