HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on July 22, 2020, from Lansing, Michigan. The Petitioner did not appear. The Department of Health and Human Services (Department) was represented by Berniece Ray Recoupment Specialist. Department Exhibit 1, pp. 1- 27 was received and admitted.

ISSUE

Did the Department properly determine that Petitioner received an overissuance of Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Respondent applied for and received FAP benefits from the Department.
2. Respondent disclosed that he had two or more felony drug convictions.
3. The Department alleges Respondent received a FAP OI during the period June 1, 2019 through March 31, 2020, due to **Department** error.
4. The Department alleges that Respondent received \$1,810 OI that is still due and owing to the Department.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), and Department of Health and Human Services Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

AGENCY ERROR EXCEPTIONS FIP, SDA, CDC and FAP

Agency error overissuances are not pursued if the estimated amount is less than \$250 per program. BAM 705

Additionally, the Department provided sufficient proof that Petitioner received an overissuance of FAP benefits totaling \$1,810. Petitioner disclosed that he had two or more felony drug convictions, but he was rewarded benefits anyway which caused the overissuance. Department policy requires that overissuances over \$250 even if they are due to agency error to be recouped. BAM 705 This was the actions taken by the Department and it was proper and correct.


The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department **did** establish a FAP benefit OI to Respondent totaling \$1,810.

DECISION AND ORDER

Accordingly, the Department is AFFIRMED.

The Department is ORDERED to initiate collection procedures for an \$1,810 OI in accordance with Department policy.
