HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 6, 2020, from Lansing, Michigan. The Petitioner was represented by herself. Ms. ██████████ served as Spanish translator. The Department of Health and Human Services (Department) was represented by Melissa Johnstone FIM. Department Exhibit 1, pp. 1-20 was received and admitted.

ISSUE

Did the Department properly determine that Petitioner was only eligible for Emergency Services Only Medical Assistance (ESO-MA) because she did not verify that she is a resident alien?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On ██████████ ██████████ 2020, Petitioner applied for MA.
2. On March 12, 2020, a Health Care Coverage Determination Notice was sent to Petitioner informing her that she and her husband were eligible for MA-ESO.
3. On April 23, 2020, Petitioner requested a hearing disputing the determination of MA-ESO.
4. Petitioner credibly testified at hearing that she is a resident alien and stated that she would provide proof of her resident alien status as soon as possible via email.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, the Department representative agreed that if Petitioner and her husband were able to verify their resident alien status then their application would be reprocessed going back to the date of application and if they meet the other eligibility requirements coverage would be activated. An email address was provided to Petitioner at hearing and she confirmed that she would send proof of her resident alien status as soon as possible.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it determined that Petitioner was only eligible for MA-ESO coverage.

DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reprocess Petitioner's MA application going back to the date of application upon receipt of verification of resident alien status.
2. Activate MA coverage if Petitioner is found otherwise eligible.
