HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on January 20, 2021, from Detroit, Michigan. Petitioner was present and represented himself. The Department of Health and Human Services (Department) was represented by Renisha Black, Assistance Payments Worker.

ISSUE

Did the Department properly close Petitioner's Food Assistance Program (FAP) benefit case?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing FAP recipient.
2. On [REDACTED], 2020, the Department sent Petitioner a redetermination form (Exhibit A, pp. 7-13).
3. On October 1, 2020, the Department sent Petitioner a Notice of Missed Appointment (Exhibit A, p. 14).
4. Effective November 1, 2020, Petitioner's FAP benefit case closed.
5. On November 16, 2020, Petitioner submitted a request for hearing disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner was an ongoing FAP recipient. On [REDACTED], 2020, the Department sent Petitioner a redetermination packet. The redetermination paperwork also advised Petitioner that he had an interview scheduled on [REDACTED], 2020. The packet was due to be returned on September 24, 2020.

The Department must periodically redetermine or renew an individual's eligibility for active programs. BAM 210 (April 2017), p. 1. Redetermination, renewal, semi-annual and mid-certification forms are often used to redetermine eligibility of active programs. BAM 210, p. 1. A complete redetermination/renewal is required at least every 12 months. BAM 210, p. 1. For FAP cases, benefits stop at the end of the benefit period unless a redetermination is completed and a new benefit period is certified. BAM 210, p. 1. If a client does not begin the redetermination process, the benefit period will be allowed to expire. BAM 210, p. 1.

The Department testified that Petitioner did not return the redetermination paperwork by his scheduled interview dated of [REDACTED], 2020 (Exhibit A, p. 15). As a result, the Department sent Petitioner a Notice of Missed Appointment. The Department testified that Petitioner did not return the redetermination prior to the end of his benefit year. As a result, Petitioner's FAP benefit case was closed.


Petitioner testified that he did not receive the redetermination paperwork. Petitioner stated that he also did not receive the Notice of Missed Appointment. Petitioner testified that he contacted his worker to request a new application. Respondent stated that he also did not receive the application.

The Department properly followed policy when it sent Petitioner the redetermination packet, as well as the Notice of Missed Appointment. The Department provided sufficient evidence that Petitioner did not submit the redetermination prior to the expiration of his FAP benefit period. Therefore, the Department acted in accordance with policy when it allowed Petitioner's FAP benefit case to close.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's FAP benefit case. Accordingly, the Department's decision is **AFFIRMED**.
