**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on February 18, 2021, from Lansing, Michigan. The Petitioner was represented by his brother and authorized representative, [REDACTED] [REDACTED]. The Department of Health and Human Services (Department) was represented by Marlon Dorsey, Family Independence Manager.

**ISSUE**

Did the Department properly determine that Petitioner was not eligible for the State of Michigan State Supplemental Income (SSI)?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of SSI because he was receiving a regular Social Security (SS) check for Social Security Income.
2. On November 16, 2020, the Department sent Petitioner a Notice of State SSI Payment Change, DHS-430, that SS informed the Department that Petitioner was longer eligible for SSI. As a result, the last State SSI payment that he would receive was issued on December 14, 2020. Department Exhibit 1, pgs. 7-9.
3. On December 4, 2020, the Department received a hearing request from Petitioner, contesting the Department's negative action.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.


In this case, Petitioner was a recipient of SS payments, which made him eligible for SSI as long as he received a regular 1st of the month check from SS. The Department was informed by SS that Petitioner was no longer a recipient of SS. Department Exhibit 1, 7-9. The Department has met their burden that the Department correctly closed the Petitioner 's SSI case because Petitioner was no longer eligible for SS benefits. BEM 105, 110, 115, 130, 210, 220, and 600. BAM 660.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that the Petitioner was no longer eligible for SSI because he was no longer eligible for SS benefits.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
