HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on 5/10/18, from Lansing, Michigan. The Petitioner appeared and testified. The Department of Health and Human Services (Department) was represented by Rebecca Jett ES worker, and Alisha Dolby ES worker.

ISSUE

Did the Department properly close Petitioner's QMB medical cost sharing case?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. At all relevant times, Petitioner was a beneficiary of the Medical (MA) Cost Sharing program.
2. Effective January 2018 and through March 2018, the department discontinued Petitioner's participation in the Cost Sharing program.
3. On 4/16/18 Petitioner filed a hearing request.
4. The Department stipulated at the administrative hearing that the Department erred in discontinuing Petitioner's participation in the program. The department further stipulated that Petitioner is owed 3 months.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, unrefuted evidence of record is that the Department erred in discontinuing Petitioner's participation in the MA QMB cost sharing program. The Department stated it was Department error, and the Petitioner is owed the 3 months of payments--from January through March 2018. The Department further testified that it has yet to make the correction and issue payments owed to Petitioner.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to act in accordance with Department policy when it stopped Petitioner's participation in the QMB cost sharing program. As such, the action must be reversed.

DECISION AND ORDER


Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reinstate Petitioner's case in the QMB cost sharing program from the date of closure, if not already done, and

2. Issue supplemental benefits to Petitioner to which she is entitled for the 3 months—from January 2018 through March 2018, if not already done, and if otherwise eligible.
