HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 18, 2018, from Lansing, Michigan. The Petitioner was represented by himself and his brother and interpreter, **Department** of Health and Human Services (Department) was represented by Valerie Foley, Hearing Facilitator.

ISSUE

Did the Department properly determine the Petitioner's eligibility for Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Petitioner was a recipient of FAP benefits with a redetermination due in October 2018. Department Exhibit 1, pgs. 2-9.
- 2. On October 31, 2018, the Department Caseworker sent the Petitioner a Notice of Case Action that his benefits were decreasing from \$973 to \$858 per month in FAP benefits.
- 3. On November 14, 2018, the Department received a hearing request from the Petitioner, contesting the Department's negative action.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, the Petitioner had a decrease in FAP benefits. He had an increase in earned income and a significant decrease in housing expenses. As a result, his FAP benefits decreased. BAM 210. BEM 500 and 554.

As a result of excess income, the Petitioner had a decrease in FAP benefits. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that the Petitioner had a decrease in FAP benefits from \$973 to \$858 due to an increase in earned income and decrease in housing expenses.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
