HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on February 14, 2019, from Lansing, Michigan. The Department was represented by Sylvia Wallace and Kelly Hudson. Petitioner was represented by his mother [REDACTED] and Petitioner testified on his own behalf.

ISSUE

Did the Department of Health and Human Services (Department) properly close Petitioner's Medical Assistance (MA)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On September 4, 2018, the Department sent Petitioner a Redetermination (DHS-1010) with an October 4, 2018, due date. Exhibit A, pp 2-9.
2. On October 19, 2018, the Department notified Petitioner that he was not eligible for Medical Assistance (MA) effective November 1, 2018. Exhibit A, pp 10-13.
3. On December 13, 2018, the Department received Petitioner's request for a hearing protesting the closure of his Medical Assistance (MA) benefits.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (January 1, 2018), p 8.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (April 1, 2017), pp 1-10.

SSI recipients who are Michigan residents receive MA-SSI for the duration of SSI eligibility. If SSI stops, the Department may have to determine continued MA eligibility. Department of Health and Human Services Bridges Eligibility Manual (BEM) 150 (April 1, 2017), p 6.

Petitioner was an ongoing MA recipient based on his receipt of SSI benefits. When Petitioner's SSI benefits closed, the Department sent him a Redetermination form to determine his eligibility under another category of benefits. When this form was not returned, Petitioner's MA benefits closed.

Petitioner's representative testified that Petitioner would later be approved for MA with a retroactive eligibility date.

However, on September 4, 2018, Petitioner's eligibility for SSI had not been verified and the Department was unable to accurately determine his eligibility for MA benefits based on the information available at that time. Therefore, the October 19, 2018, closure of

MA benefits was a proper application of Department policy at that time. As Petitioner's circumstances change, his eligibility for benefits and/or retroactive benefits may also change.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Medical Assistance (MA) benefits on October 19, 2018.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
