## **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on March 13, 2019, from Detroit, Michigan. Petitioner was present and represented herself. The Department of Health and Human Services (Department) was represented by Valarie Foley, Hearing Facilitator.

### **ISSUE**

Did the Department properly determine Petitioner's Medical Assistance (MA) eligibility?

### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner was an ongoing MA recipient under the Healthy Michigan Plan (HMP) program.
- 2. On November 29, 2018, the Department redetermined Petitioner's MA eligibility as some discrepancies were discovered between information reported to the Department and Petitioner's MA benefit case information.
- 3. On November 29, 2018, the Department sent Petitioner a Health Care Coverage Determination Notice (HCCDN) informing her that she was approved for MA benefits subject to a monthly deductible of **Sector** effective January 1, 2019, ongoing.
- 4. On January 18, 2019, Petitioner submitted a request for hearing disputing the Department's actions.

### CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner submitted a request for hearing disputing the Department's decision to remove her from the full-coverage HMP MA program to a program with a monthly deductible. The Department testified that information was received that there was a discrepancy between data that was reported to the Department and the information in Petitioner's MA benefit case. As a result, Petitioner's MA eligibility was reprocessed.

The Department concluded that Petitioner was not eligible for HMP because her household income exceeded the applicable income limit for her group size. HMP uses a Modified Adjusted Gross Income (MAGI) methodology. BEM 137 (April 2018), p. 1. An individual is eligible for HMP if her household's income does not exceed 133% of the Federal Poverty Level (FPL) applicable to the individual's group size. BEM 137, p. 1.

An individual's group size for MAGI-related purposes requires consideration of the client's tax filing status. BEM 211 (January 2016), pp. 1-2. The household for a tax filer, who is not claimed as a tax dependent, consists of: (i) the individual; (ii) the individual's spouse; and (iii) and tax dependents. BEM 211, pp. 1-2.

The Department testified that Petitioner's group size was two, which consisted of Petitioner and her husband. However, Petitioner lives with her two granddaughters and claims them both as tax dependents. The Department could not explain why Petitioner's granddaughters were not included in her MA group.

Per policy, Petitioner's granddaughters should have been included in her MA group, as she claims them as tax dependents. As such, the Department did not follow policy when determining Petitioner's MA group composition and MA eligibility.

## DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it determined Petitioner's MA eligibility.

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

- 1. Redetermine Petitioner's MA eligibility as of January 1, 2019, ongoing;
- 2. If Petitioner is eligible for MA benefits, provide her with MA coverage she is entitled to receive as of January 1, 2019, ongoing; and
- 3. Notify Petitioner of its decision in writing.
