## **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on March 27, 2019, from Lansing, Michigan. Petitioner was represented by himself. The Department was represented by Rechela Hall.

### <u>ISSUE</u>

Did the Department of Health and Human Services (Department) properly close Petitioner's Medical Assistance (MA) and Food Assistance Program (FAP) benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On December 26, 2016, the Department received Petitioner's Redetermination (DHS-1010) form. Exhibit A, pp 4-11.
- 2. On January 23, 2018, the Department sent Petitioner a Verification Checklist (DHS-3503) requesting verification of the balance of a checking account by February 4, 2019. Exhibit A, p 12.
- 3. On February 8, 2019, the Department notified Petitioner that he was no longer eligible for Food Assistance Program (FAP) benefits effective February 1, 2019. Exhibit A, pp 13-14.

- 4. On February 8, 2019, the Department notified Petitioner that he was no longer eligible for Medical Assistance (MA) effective March 1, 2019. Exhibit A, pp 23-24.
- 5. On February 14, 2019, the Department received Petitioner's request for a hearing protesting the closure of his Medical Assistance (MA) and Food Assistance Program (FAP) benefits. Exhibit A, pp 2-3.

#### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (January 1, 2018), p 8.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (April 1, 2017), pp 1-10.

Petitioner was an ongoing MA and FAP recipient when the Department received his Redetermination (DHS-1010) form. On January 23, 2018, the Department requested that Petitioner provide verification of the balance of a checking account that was not verified with the December 26, 2016, Redetermination form, but that the Department was aware of. When Petitioner failed to provide verification of the checking account in a timely manner, the Department closed his MA and FAP benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Medical Assistance (MA) and Food Assistance Program (FAP) for failure to provide the Department with information necessary to determine his eligibility to receive benefits.

#### **DECISION AND ORDER**

Accordingly, the Department's decision is AFFIRMED.
