HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on April 3, 2019, from Lansing, Michigan. Petitioner represented himself. The Department was represented by Valarie Foley.

ISSUE

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for the Food Assistance Program (FAP) and Medical Assistance (MA)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On February 8, 2019, the Department sent Petitioner an Out of State Benefit Match Notice (DHS-4600) requesting verification that a member of Petitioner's benefits group was a Michigan resident by February 19, 2019, or all benefits would be cancelled. Exhibit A, pp 8-9.
2. On February 19, 2019, the Department notified Petitioner that he was not eligible for Food Assistance Program (FAP) benefits as of April 1, 2019. Exhibit A, pp 4-5.
3. On February 20, 2019, the Department notified Petitioner that he was no eligible for Medical Assistance (MA) benefits as of April 1, 2019. Exhibit A, pp 6-7.

4. On February 25, 2019, the Department received Petitioner's request for a hearing. Exhibit A, pp 2-3.
5. On February 25, 2019, the Department received Petitioner's Out of State Benefit Match Notice (DHS-4600). Exhibit A, pp 10-11.
6. On March 4, 2019, the Department reinstated Petitioner's Food Assistance Program (FAP) and Medical Assistance (MA) benefits. Exhibit A, pp 12-15.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

To be eligible for FAP benefits, a person must be a Michigan resident. A person is considered a resident under the FAP while living in Michigan for any purpose other than a vacation, even if there is no intent to remain in the state permanently or indefinitely. A Michigan resident is eligible for MA benefits who is living in Michigan except for a temporary absence. Department of Health and Human Services Bridges Eligibility Manual (BEM) 220 (April 1, 2018), pp 1-2.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (January 1, 2018), p 8.

Reinstatement restores a closed program to active status without completion of a new application. Closed programs may be reinstated for complying with program requirements before the negative action date. Department of Health and Human Services Bridges Administrative Manual (BAM) 205 (July 1, 2015), p 1.

Petitioner was an ongoing FAP and MA recipient on February 8, 2019, when the Department sent him an Out of State Benefit Match Notice (DHS-4600) with a February 19, 2019, due date. The Department instructed him that all benefits would close if the form was not returned. On February 19, 2019, the Department closed Petitioner's FAP benefits. On February 20, 2019, the Department closed Petitioner's MA benefits. On March 4, 2019, the Department reinstated Petitioner's MA and FAP benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for Medical Assistance (MA) and Food Assistance Program (FAP) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
