## **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on August 1, 2019, from Lansing, Michigan. Petitioner represented himself. The Department of Health and Human Services was represented by Tiffany Dixon and Lori Turner.

#### **ISSUE**

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for the Food Assistance Program (FAP)?

#### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Department received Petitioner's Redetermination (DHS-1010) form on May 23, 2019. Exhibit A, pp 6-11.
- 2. Petitioner reported on his May 23, 2019, Redetermination form that he has no expenses that he is required to pay and that he had no housing expenses. Exhibit A, p 9.
- 3. Petitioner receives monthly earned income from employment in the gross monthly amount of \$1,243. Exhibit A, pp 13-14.
- 4. On June 28, 2019, the Department received Petitioner's request for a hearing protesting the size of his Food Assistance Program (FAP) allotment. Exhibit A, pp 3-4.

#### CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Department will verify shelter expenses at application and when a change is reported. If the client fails to verify a reported change in shelter, the Department will remove the old expense until the new expense is verified. Department of Health and Human Services Bridges Eligibility Manual (BEM) 554 (August 1, 2017), p 14.

Petitioner was an ongoing FAP recipient on May 23, 2019, when the Department received Petitioner's Redetermination (DHS-1010) form. Petitioner reported his income of \$1,243, which was determined from the two paychecks he received and were verified to the Department. Petitioner also reported that he has no expenses that he is required to pay and has no housing expenses. Petitioner was given the standard heat and utility deduction, but it is not clear whether this is a deduction for sharing the utility expenses at this home or whether he receives a home heating credit.

Petitioner's adjusted gross income of \$836 was determined by reducing his total income by the \$158 standard deduction. Petitioner reported no childcare or dependent care expenses to the Department.

The Department gave Petitioner a \$125 shelter deduction, which was determined by reducing the heat and utility standard deduction by 50% of his adjusted gross income as directed by BEM 556.

Petitioner's net income of \$711 was determined by reducing his adjusted gross income by the shelter deduction. A benefit group of one with a net income of \$711 is entitled to a \$15 monthly allotment of FAP benefits. Department of Health and Human Services Reference Table Manual (RFT) 260 (October 1, 2018), p 10.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for the Food Assistance Program (FAP).

### **DECISION AND ORDER**

Accordingly, the Department's decision is AFFIRMED.
