HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on August 8, 2019, from Lansing, Michigan. Petitioner represented herself. The Department was represented by Amanda Mullen, Julie Bair, and Armmando Diaz.

ISSUE

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for the Food Assistance Program (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On July 3, 2019, the Department sent Petitioner a Verification Checklist (DHS-3503) requesting verification of earned income. Exhibit A, pp 15-16.
- 2. On June 28, 2019, the Department received verification of Petitioner's earned income from employment. Exhibit A, pp 9-12.
- 3. Petitioner receives monthly earned income in the gross monthly amount of \$1,021.80. Exhibit A, pp 15-16.
- 4. Petitioner receives monthly child support income in the gross monthly amount of \$65.21. Exhibit A, p 50-52.
- 5. On July 1, 2019, the Department received Petitioner's request for a hearing. Exhibit A, pp 23-24.

6. On July 15, 2019, the Department notified Petitioner that she was eligible for Food Assistance Program (FAP) benefits as a group of three with a \$382 monthly allotment as of August 1, 2019. Exhibit A, p 48.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

All earned and unearned income available is countable unless excluded by policy. Earned income means income received from another person or organization or from self-employment for duties for duties that were performed for compensation or profit. Unearned income means all income that is not earned, including but not limited to funds received from the Family Independence Program (FIP), State Disability Assistance (SDA), Child Development and Care (CDC), Medicaid (MA), Social Security Benefits (RSDI/SSI), Veterans Administration (VA), Unemployment Compensation Benefits (UCB), Adult Medical Program (AMA), alimony, and child support payments. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. Department of Human Services Bridges Eligibility Manual (BEM) 500 (July 1, 2017).

All income is converted to a standard monthly amount. If the client is paid weekly, the Department multiplies the average weekly amount by 4.3. If the client is paid every other week, the Department multiplies the average bi-weekly amount by 2.15. Department of Human Services Bridges Eligibility Manual (BEM) 505 (October 1, 2017), pp 7-8.

Petitioner was an ongoing FAP recipient as a group of three when the Department requested verification of her earned income from employment. Petitioner had reported that she receives earned income from employment and child support income. On June 28, 2019, the Department received verification of Petitioner's earned income.

However, this verification did not clearly show that Petitioner's income would be interrupted due to the seasonal nature of her employment. Later, Petitioner provided verification that that her income would be reduced and that some of the income she was receiving was not likely to continue in the future.

On July 15, 2019, the Department redetermined Petitioner's eligibility for FAP benefits and notified her that she was eligible for a \$382 monthly allotment of FAP benefits. The evidence supports a finding that the Department used the most accurate information available to determine Petitioner's eligibility for FAP benefits as of August 1, 2019.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for Food Assistance Program (FAP) benefits as of August 1, 2019.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
