HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a three-way telephone hearing was held on August 21, 2019, from Detroit, Michigan. The Petitioner was represented by [REDACTED] Authorized Hearing Representative (AHR). The Department of Health and Human Services (Department) was represented by [REDACTED], Eligibility Specialist.

ISSUE

Did the Department timely process medical expenses to allow Petitioner to become eligible for Medical Assistance (MA) benefits for March 2019?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is an ongoing recipient of MA benefits.
2. On April 18, 2019, medical bills were sent to the Department to meet the March 2019 deductible.
3. The Department failed to process Petitioner's medical bills.
4. On July 3, 2019, Petitioner's AHR filed a Request for Hearing disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner is eligible for MA benefits subject to a deductible. Deductible is a process which allows a client with excess income to become eligible for Group 2 MA if sufficient allowable medical expenses are incurred. BEM 545 (July 2019), p. 10. Further, meeting a deductible means reporting and verifying allowable medical expenses that equal or exceed the deductible amount for the calendar month tested. BEM 545, p. 11.

Petitioner's AHR testified that 21 pages of medical bills were sent to the Department by facsimile on April 18, 2019 by a patient representative. Petitioner's AHR provided a confirmation sheet in support of this assertion. The Department confirmed that the facsimile number articulated by Petitioner's AHR on the record was the correct number where the documents were to be sent. The Department maintained that it did not receive Petitioner's medical records. Petitioner's AHR further testified that she personally sent the same medical bills by facsimile on July 16, 2019 to the same facsimile number and also received a confirmation sheet that the facsimile was successful. Again, the Department testified that it did not receive the July 16, 2019 documents.

The evidence presented at the hearing revealed that the medical bills were properly sent to the Department on April 18, 2019. It appears that the documents were misplaced or not scanned into Petitioner's file. Petitioner's AHR agreed to send the medical bills directly to the local office following the conclusion of the hearing.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it failed to scan Petitioner's medical bills into her case file and process the bills to determine whether the bills were sufficient to meet Petitioner's deductible for March 2019.


DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Process Petitioner's medical bills relating to the March 2019 deductible; and
2. Notify Petitioner and her AHR of its decision in writing.
