### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on November 6, 2019, from Lansing, Michigan. Petitioner was represented by her Authorized Representative (AR) [REDACTED] [REDACTED]. The Department of Health and Human Services was represented by Karina Littles.

### **ISSUE**

Did the Department of Health and Human Services (Department) properly close Petitioner's State Supplemental Security Income (SSP) benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing State Supplemental Security Income (SSP) recipient.
2. Petitioner's Supplemental Security Income (SSI) benefits from the Social Security Administration (SSA) closed.
3. On August 26, 2019, the Department notified Petitioner that her State Supplemental Security Income (SSP) benefits would close.
4. On September 11, 2019, the Department received Petitioner's request for a hearing protesting the closure of State Supplemental Security Income (SSP) benefits.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

Supplemental Security Income (SSI) is a cash benefit to needy persons who are aged (at least 65), blind or disabled. It is a federal program administered by the Social Security Administration (SSA). States are allowed the option to supplement the federal benefit with state funds. In Michigan SSI benefits include a basic federal benefit and an additional amount paid with state funds. The amount of the state benefit varies by living arrangement. The SSA issues SSP benefits for SSI recipients based on living arrangement. Department of Health and Human Services Bridges Eligibility Manual (BEM) 660 (January 1, 2017), p 1.

Petitioner was an ongoing SSP recipient based on her receipt of SSI benefits. When Petitioner's SSI benefits closed, the Department closed Petitioner's SSP benefits.


Petitioner's representative did not dispute that Petitioner's SSI, a federal benefit administered by SSA, had closed. Petitioner's representative testified that she had initiated reinstatement of SSI benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Supplemental Security Income (SSI) benefits because she was not an active recipient of Supplemental Security Income (SSI) benefits.

### **DECISION AND ORDER**

Accordingly, the Department's decision is AFFIRMED.
