HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16, 42 CFR 431.230(b), and 45 CFR 235.110, and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on December 3, 2019, from Lansing, Michigan. The Department was represented by Meghan Kerr, #149, Regulation Agent of the Office of Inspector General (OIG). Respondent was represented by herself.

ISSUES

- 1. Did Respondent receive an over issuance (OI) of Food Assistance Program (FAP) benefits that the Department is entitled to recoup?
- 2. Did the Department establish, by clear and convincing evidence, that Respondent committed an Intentional Program Violation (IPV)?
- 3. Should Respondent be disqualified from receiving benefits for one year?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Department's OIG filed a hearing request on September 16, 2019, to establish an OI of benefits received by Respondent as a result of Respondent having allegedly committed an IPV.

- 2. The OIG has requested that Respondent be disqualified from receiving FAP benefits.
- 3. Respondent was a recipient of FAP benefits issued by the Department. Department Exhibit 1, pgs. 43-44.
- 4. On the Redetermination Application, DHS-1010, signed by Respondent on January 20, 2015, Respondent reported that she understood the responsibility to report changes in household income to the Department within 10 days where she reported her Social Security income and her son's unemployment income. Department Exhibit 1, pgs. 12-17.
- 5. Respondent was aware of the responsibility to report changes in household income within 10 days. She failed to report her son's unemployment ending and his employment at Mackinaw Family Market with a first paycheck received on May 15, 2015. Respondent did not report that her son's seasonal income ended with his last check on October 29, 2015, with the resumption of his unemployment benefits until her Redetermination Application, DHS-1010, signed by Respondent on January 21, 2016. Department Exhibit 1, pgs. 28-44.
- 6. Respondent had no apparent physical or mental impairment that would limit the understanding or ability to fulfill this requirement. During the hearing, she stated that she had multiple sclerosis (MS) and could not remember if she reported the changes but doesn't believe that she owes. There was no medical documentation provided about her medical condition.
- 7. The Department's OIG indicates that the time period it is considering the fraud period is July 1, 2015, through February 29, 2016 (fraud period).
- 8. During the fraud period, Respondent was issued \$1,279.00 in benefits by the State of Michigan, and the Department alleges that Respondent was entitled to \$96.00 in such benefits during this time period.
- 9. The Department alleges that Respondent received an OI in FAP benefits in the amount of \$1,183.00.
- 10. This was Respondent's first alleged IPV.
- 11. A notice of hearing was mailed to Respondent at the last known address and was not returned by the US Post Office as undeliverable.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), Adult Services Manual (ASM), and Reference Tables Manual (RFT). The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10; the Social Welfare Act, MCL 400.1-.119b; and Mich Admin Code, R 400.3001 to .3015.

Effective January 1, 2016, the Department's OIG requests IPV hearings for the following cases:

- Willful overpayments of \$500.00 or more under the AHH program.
- FAP trafficking overissuances that are not forwarded to the prosecutor.
- Prosecution of welfare fraud or FAP trafficking is declined by the prosecutor for a reason other than lack of evidence, and
 - The total amount for the FIP, SDA, CDC, MA and FAP programs combined is \$500 or more, or
 - the total amount is less than \$500, and
 - the group has a previous IPV, or
 - > the alleged IPV involves FAP trafficking, or
 - the alleged fraud involves concurrent receipt of assistance (see BEM 222), or
 - the alleged fraud is committed by a state/government employee.

BAM 720 (1/1/16), p. 12-13.

Intentional Program Violation

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The client intentionally failed to report information **or** intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and
- The client was clearly and correctly instructed regarding his or her reporting responsibilities, and

• The client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill reporting responsibilities.

BAM 700, p. 6; BAM 720, p. 1.

An IPV is also suspected for a client who is alleged to have trafficked FAP benefits. BAM 720, p. 1.

An IPV requires that the Department establish by clear and convincing evidence that the client has intentionally withheld or misrepresented information for the **purpose** of establishing, maintaining, increasing or preventing reduction of program benefits or eligibility. BAM 720, p. 1 (emphasis in original); see also 7 CFR 273.16(e)(6). Clear and convincing evidence is evidence sufficient to result in a clear and firm belief that the proposition is true. See M Civ JI 8.01.

Disqualification

A court or hearing decision that finds a client committed IPV disqualifies that client from receiving program benefits. BAM 720, p. 12. A disqualified recipient remains a member of an active group as long as he lives with them, and other eligible group members may continue to receive benefits. BAM 720, p. 13.

Clients who commit an IPV are disqualified for a standard disqualification period except when a court orders a different period, or except when the OI relates to MA. BAM 720, p. 13. Refusal to repay will not cause denial of current or future MA if the client is otherwise eligible. BAM 710, p. 2. Clients are disqualified for periods of one year for the first IPV, two years for the second IPV, lifetime disqualification for the third IPV, and ten years for a FAP concurrent receipt of benefits. BAM 720, p. 16.

Overissuance

When a client group receives more benefits than they are entitled to receive, the Department must attempt to recoup the OI. BAM 700, p. 1.

In this case, Respondent was aware of the responsibility to report changes in household income within 10 days. She failed to report her son's unemployment ending and his employment at Mackinaw Family Market with a first paycheck received on May 15, 2015. Respondent did not report that her son's seasonal income ended with his last check on October 29, 2015, with the resumption of his unemployment benefits until her Redetermination Application, DHS-1010, signed by Respondent on January 21, 2016. Department Exhibit 1, pgs. 28-44. As a result, Respondent received an over issuance of FAP benefits in the amount of \$1,183.00 that the Department is required to recoup. In addition, she is sanctioned from receiving FAP benefits for one year as her first IPV. Department Exhibit, pgs. 1-58.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

- 1. The Department has established by clear and convincing evidence that Respondent did commit an intentional program violation (IPV).
- 2. Respondent did receive an OI of program benefits in the amount of \$1,183.00 from the Food Assistance Program (FAP).

The Department is ORDERED to initiate recoupment procedures for the amount of \$1,183.00 in accordance with Department policy.

It is FURTHER ORDERED that Respondent be disqualified from the Food Assistance Program (FAP) for a period of 12 months.
