### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 12, 2019, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Dewanda Holley, Eligibility Specialist.

### **ISSUE**

Did the Department properly determine Petitioner's eligibility for Medical Assistance (MA)?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of MA for his son ([REDACTED]) with a redetermination due in October 2019.
2. On October 4, 2019, the Department Caseworker received Petitioner's Redetermination Application, DHS-1010, that listed his son's Social Security RSDI benefits of \$[REDACTED]. Department Exhibit 1, pgs. 7-10.
3. On October 7, 2019, the Department Caseworker sent Petitioner a Health Care Coverage Determination Notice, DHS-1606, that [REDACTED] was not eligible for MA effective November 1, 2019, due to excess income. Department Exhibit 1, pgs. 11-13.

4. On October 28, 2019, the Department received a hearing request from the Petitioner contesting the Department's negative action.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, the Department Caseworker determined during the October redetermination that the Department had not been counting Petitioner's son, D.E.C.'s RSDI income of \$ [REDACTED] from Social Security. As a result, Petitioner's son had previously been found eligible for MA due to Department error. Petitioner's household income was \$ [REDACTED]. Once the RSDI income was added to the MA budget, the Petitioner's household of three had excess income for MA, which had an income limit of \$45,219.60 for a group size of 3. Petitioner is eligible to buy health insurance from the marketplace. BEM 500, 503, and 530.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that Petitioner had excess income for MA.

Accordingly, the Department's decision is **AFFIRMED**.
