HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, 7 CFR 273.15, and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on January 9, 2020, from Lansing, Michigan. Petitioner, appeared and represented herself. Respondent, Department of Health and Human Services (Department), had Olivetta Gordon, Family Independence Manager, appear as its representative. Neither party had any additional witnesses.

ISSUE

Did the Department properly close Petitioner's Food Assistance Program (FAP) benefits for failing to return a completed semi-annual contact form?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner was a FAP recipient.
- 2. On November 10, 2019, the Department mailed a notice of food assistance closure to Petitioner to notify her that her FAP benefits were closed for failing to return a completed semi-annual contact form.
- 3. Petitioner had not received a semi-annual contact form prior to the closure, and the Department had not issued a semi-annual contact form prior to the closure.
- 4. On December 4, 2019, Petitioner requested a hearing.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner presented sufficient evidence to establish that the Department did not properly close her FAP benefits because the Department did not act in accordance with its policies. The Department was required to send a semi-annual contact form to Petitioner. BAM 210 (October 1, 2019), p. 11. The Department did not send a semi-annual contact form to Petitioner before the Department closed her case for failing to return the semi-annual contact form. Since the Department did not send the semi-annual contact form to Petitioner, the Department did not act in accordance with its policies and Petitioner did not have a fair opportunity to return the semi-annual contact form to the Department. For these reasons, the Department's decision is reversed.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with its policies and the applicable law when it closed Petitioner's FAP benefits for failing to return a completed semi-annual contact form

IT IS ORDERED the Department's decision is **REVERSED**. The Department shall begin to implement this decision within ten days.
