HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on February 27, 2020, from Lansing, Michigan. Petitioner represented herself. The Department was represented by Crystal Hackney and Nalo Bain.

ISSUE

Did the Department of Health and Human Services (Department) properly close Petitioner's Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing Food Assistance Program (FAP) recipient.
2. On December 2, 2019, the Department sent Petitioner a Mid-Certification Contact Notice (DHS-2240-A) with a January 1, 2020, due date. Exhibit A, pp 6-8.
3. On January 10, 2020, the Department sent Petitioner a Notice of Food Assistance (FAP) Closure (DHS-2240-B) instructing her that her benefits would close effective January 31, 2020, for failing to complete the mid-certification form. Exhibit A, p 5.
4. On December 10, 2019, Petitioner faxed 25 pages of material to [REDACTED]. Petitioner's Exhibit 1.

5. On January 23, 2020, Petitioner faxed 26 pages of material of [REDACTED]. Petitioner's Exhibit 1.
6. On [REDACTED] [REDACTED] [REDACTED] the Department received Petitioner's request for a hearing protesting the closure of her Food Assistance Program (FAP) benefits. Exhibit A, pp 3-4.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (October 1, 2019), p 9.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (April 1, 2017), pp 1-10.

Petitioner was an ongoing FAP recipient on December 2, 2019, when the Department initiated a routine review of her eligibility for ongoing benefits by sending her a Mid-Certification Contact Notice with a January 1, 2020, due date. When this form was not received by the Department, Petitioner's FAP benefits closed as of January 31, 2020.

Petitioner testified that she filed the required form to the Department on two occasions. Petitioner provided a date stamped fax receipt showing that she faxed some documents, and it is her claim that these documents were the Mid-Certification Contact Notice.

However, Petitioner's fax receipt does not confirm that she faxed anything to the Department, but the documents were instead sent to some unknown fax number.


Petitioner had a duty to provide the Department with information necessary to accurately determine her eligibility for ongoing FAP benefits, and it was due to Petitioner's error that this information was not supplied to the Department in a timely manner.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Food Assistance Program (FAP) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
