HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 12, 2020 from Detroit, Michigan. Petitioner appeared and represented herself. The Department of Health and Human Services (Department) was represented by Haysem Hosny, Hearings Coordinator.

ISSUE

Did the Department properly Petitioner's eligibility for Food Assistance Program (FAP) benefits, effective July 1, 2020?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner was an ongoing recipient of FAP benefits from the Department.
- 2. On June 18, 2020, the Department issued to Petitioner a Notice of Case Action informing Petitioner that she was eligible for per month in FAP benefits, effective July 1, 2020.
- 3. On ______, 2020, Petitioner submitted to the Department a request for hearing objecting to the Department's determination of her monthly FAP benefits.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner objected to the Department's determination of her FAP eligibility, effective July 1, 2020. In determining Petitioner's eligibility, the Department took into consideration Petitioner's reported and verified income and expenses. For income, the Department factored in \$ in unearned monthly income, which was confirmed as correct during the hearing.

The standard deduction of \$161 must be taken out of Petitioner's gross income to arrive at a figure of \$162. RFT 255 (January 2020), p. 1. Petitioner did not report any child care, medical, or child support expenses, resulting in an adjusted gross income of \$162.

Petitioner was eligible for the excess shelter deduction, which works to further reduce Petitioner's income. Petitioner had verified housing costs of \$375. Petitioner also qualified for the heat/utility standard of \$518. BEM 554 (January 2020), pp. 15-16. Adding Petitioner's housing expenses together results in total shelter expenses of \$893. The excess shelter deduction is calculated by subtracting from the total shelter expense figure (\$) one half of the adjusted gross income, which is \$ \text{ The remaining amount, if greater than zero, is the excess shelter deduction. The remaining amount is \$316.

Petitioner's net income is then calculated by subtracting the excess shelter deduction of \$316 from the adjusted gross income of \$316, which equals \$316. The Food Assistance Issuance Table shows \$316 in monthly FAP benefits for a household of one with a net income of \$316 RFT 260 (October 2019), p. 12. That is what the Department determined and is correct. Thus, the Department is affirmed.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for FAP benefits, effective July 1, 2020.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
