HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on October 22, 2020, from Detroit, Michigan. Petitioner was present and represented herself. The Department of Health and Human Services (Department) was represented by Sonya Bell, Assistance Payments Worker and Juwan Gary, Assistance Payments Supervisor.

<u>ISSUE</u>

Did the Department properly deny Petitioner's Food Assistance Program (FAP) application?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On pp. 17-23).
- 2. Petitioner's household consisted of herself, her Living Together Partner (LTP) and her two minor children.
- 3. Petitioner had earned income from employment (Exhibit A, pp. 26-27).
- 4. Petitioner's LTP had earned income from employment (Exhibit A, pp. 24-25).
- 5. On September 2, 2020, the Department sent Petitioner a Notice of Case Action informing her that her FAP application was denied, as she exceeded the gross income limit for her group size (Exhibit A, pp. 37-40).

6. On September 11, 2020, Petitioner submitted a request for hearing disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner submitted an application for FAP benefits on ______, 2020. The Department denied Petitioner's FAP application for exceeding the gross income limits for her group size. A non-categorically eligible, non-SDV FAP group must have income below the gross and net income limits. BEM 550 (January 2017), p. 1. Gross income limitations are based on group size and are set forth in RFT 250.

All countable earned and unearned income available to the client must be considered in determining a client's eligibility for program benefits and group composition policies specify whose income is countable. BEM 500 (July 2017), pp. 1-5. The Department determines a client's eligibility for program benefits based on the client's actual income and/or prospective income. Prospective income is income not yet received but expected. BEM 505 (October 2017), pp. 1-2. In prospecting income, the Department is required to use income from the past 30 days if it appears to accurately reflect what is expected to be received in the benefit month, discarding any pay if it is unusual and does not reflect the normal, expected pay amounts. BEM 505, pp. 5-6. A standard monthly amount must be determined for each income source used in the budget. BEM 505, pp. 7-8. Income received biweekly is converted to a standard amount by multiplying the average of the biweekly pay amounts by the 2.15 multiplier. BEM 505, pp. 7-9. Income received weekly is multiplied by a 4.3 multiplier. BEM 505, pp. 7-9. Income received twice per month is added together. BEM 505, pp. 7-9. An employee's wages include salaries, tips, commissions, bonuses, severance pay and flexible benefit funds not used to purchase insurance. The Department counts gross wages in the calculation of earned income. BEM 501 (January 2020), pp. 6-7.

Per the Notice of Case Action issued on September 2, 2020, the Department determined that Petitioner's household had a standard monthly gross income of \$ The Department presented pay statements from Petitioner's employment. Petitioner was paid on July 3, 2020, in the gross amount of \$ and on July 17, 2020, in the

gross amount of \$ ______ The Department also provided pay statements from Petitioner's LTP's employment. Petitioner's LTP was paid on June 19, 2020, in the gross amount of \$ ______ and on July 3, 2020, in the gross amount of \$ ______ Both Petitioner and her LTP were paid on a biweekly basis. When averaging Petitioner's and Petitioner's LTP's income and multiplying by the 2.15 multiplier, it results in a standard monthly household income of \$ ______ Therefore, the Department properly determined Petitioner's household gross income.

Because all FAP applicants and recipients are eligible for enhanced authorization for Domestic Violence Prevention Services (DVPS), the monthly categorical income limit (200% of the poverty level), from RFT 250, column D (October 2019), p. 1, applies as the standard for FAP gross income eligibility. BEM 213 (January 2016), pp. 1-2. For a four-person FAP group, the applicable 200% gross income limit is \$4,292. As Petitioner's household gross income was \$ 100, the gross income limit for FAP eligibility was exceeded. Thus, Petitioner is not entitled to FAP benefits and the Department properly denied her application.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied Petitioner's application for FAP benefits due to exceeding the gross income limit. Accordingly, the Department's decision is **AFFIRMED**.
