HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on January 26, 2021, from Lansing, Michigan. The Petitioner [REDACTED] self-represented. The Department of Health and Human Services (Department or Respondent) was represented by Valarie Foley, Hearings Facilitator.

Department's Exhibits 1-14 were admitted as evidence.

ISSUE

Did the Department properly determine Petitioner's Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is a Food Assistance Program benefit recipient, receiving FAP for a group size of seven people.
2. On [REDACTED], 2020, Petitioner filed a State Emergency Relief (SER) application for a DTE bill, indicating on the application that she was a household of one person.
3. Petitioner did not answer interview questions.
4. On November 9, 2020, Petitioner reported that her daughter MM, aged 21 moved out of the household on November 1, 2020, along with her income (unemployment SSI proof).

5. The Department updated the information and certified an increase if FAP benefits for Petitioner.
6. On November 18, 2020, Petitioner filed a Request for Hearing to contest the amount of Food Assistance Program benefits she has been determined eligible for and to contest a State Emergency Relief determination.
7. On November 23, 2020, the Michigan Office of Administrative Hearings and Rules received a Hearing summary and attached documents.
8. The Department did not address the FAP claim at the hearing or in its Hearing Summary packet.
9. Petitioner is not contesting the SER determination.

CONCLUSIONS OF LAW

The regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code, MAC R 400.901-400.951. An opportunity for a hearing shall be granted to an applicant who requests a hearing because his or her claim for assistance has been denied. MAC R 400.903(1). Clients have the right to contest a department decision affecting eligibility or benefit levels whenever it is believed that the decision is incorrect. The department will provide an administrative hearing to review the decision and determine the appropriateness of that decision. BAM 600.

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Michigan Office of Administrative Hearings and Rules (MOAHR) may grant a hearing for any of the following:

- Denial of an application and/or supplemental payments.
- Reduction in the amount of program benefits or service.
- Suspension or termination of program benefits or service.

- Restrictions under which benefits, or services are provided.
- Delay of any action beyond standards of promptness.
- For FAP only, the current level of benefits or denial of expedited service. BAM 600 (April 1, 2017), pp 3-4.

The client or AHR has 90 calendar days from the date of the written notice of case action to request a hearing. The request must be received in the local office within the 90 days. BAM 600, page 6

Petitioner requested a hearing on the FAP case. The Department did not address the FAP case at all.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department has not established by the necessary competent, material and substantial evidence on the record that it was acting in accordance with Department policy when it failed to address the entire the hearing request.


DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reassess Petitioner's eligibility for FAP benefits from November 2020 forward.
2. If Petitioner is otherwise eligible pay to Petitioner any additional FAP benefits to which she is entitled.
