

#### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on July 15, 2021, from Lansing, Michigan. The Petitioner who is deceased was represented by his brother and authorized representative,

The Department of Health and Human Services (Department) was represented by Rebecca Ferrille, Assisted Payments Supervisor.

## **ISSUE**

Did the Department properly deny the Petitioner's application for State Emergency Relief (SER)?

# **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On the Petitioner died.
- 2. On April 1, 2021, the Petitioner was cremated.
- 3. On 2021, the Department received a SER application for cremation that was signed on April 16, 2021, by the Petitioner's brother and authorized representative. Department Exhibit 1, pg. 8.
- 4. On April 21, 2021, the Department sent the Petitioner a SER Decision Notice, DHS 1419, that the application was denied because Department policy requires the application to be filed within 10 business days after cremation, per ERM 306, page 1. The Petitioner's cremation occurred on April 1, 2021, but the application was not received to the Department until 20 days later, on April 21, 2021. Department Exhibit 1, pg. 10.

5. On May 26, 2021, the Department received a hearing request from the Petitioner's brother and authorized representative.

## **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Department of Human Services) pursuant to MCL 400.10 and Mich Admin Code, R 400.7001-.7049.

In this case, the Petitioner died on Communication On April 1, 2021, the Petitioner was cremated. On April 21, 2021, the Department received a SER application for cremation that was signed on April 16, 2021, by the Petitioner's brother and authorized representative. Department Exhibit 1, pg. 8.

On April 21, 2021, the Department sent the Petitioner a SER Decision Notice, DHS 1419, that the application was denied because Department policy requires the application to be filed within 10 business days after cremation, per ERM 306, page 1. The Petitioner's cremation occurred on April 1, 2021, but the application was not received to the Department until 20 days later, on April 21, 2021. Department Exhibit 1, pg. 10. On May 26, 2021, the Department received a hearing request from the Petitioner's brother and authorized representative.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that the SER application for cremation received by the Department on April 21, 2021, but signed on April 16, 2021, was not within the 10 business days required by Department policy when the Petitioner was cremated on April 1, 2021.

Accordingly, the Department's decision is **AFFIRMED**.
