**ORDER OF DISMISSAL**

On July 19, 2022, the Michigan Office of Administrative Hearings and Rules (MOAHR) received from counsel for Petitioner, ██████████ Petitioner's Request for Re-hearing. On December 1, 2022, MOAHR received from counsel for Petitioner and the Assistant Attorney General, a Stipulation to Withdraw Hearing Request signed by the aforementioned parties. The MOAHR records show that the only pending hearing request from Petitioner concerned the request the Michigan Department of Health and Human Services (MDHHS) received from Petitioner (**OR** Petitioner's counsel) on March 8, 2021, to have Petitioner's name expunged from the Michigan Child Abuse and Neglect Central Registry (Central Registry) in connection with a Child Protective Services investigation for a complaint dated July 9, 2020. The matter was docketed under MOAHR docket no. 21-006089.

**IT IS ORDERED** that, because Petitioner no longer seeks a rehearing or reconsideration on the issue of expunction from the Central Registry in connection with a Child Protective Services investigation dated July 9, 2020, this matter is **DISMISSED**.
