ORDER OF DISMISSAL

Following a request for hearing from Petitioner's authorized hearing representative (AHR), this matter is before the undersigned administrative law judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference line on April 7, 2022. Petitioner participated and was represented. **Control of Control of C**

Petitioner requested a hearing to dispute a termination of Medical Assistance (MA) benefits. Exhibit A, p. 3. Petitioner testified that the MA termination was to begin December 2021 and that he was only disputing his own MA eligibility.²

During the hearing, MDHHS testified that Petitioner's MA eligibility was approved that morning. MDHHS's testimony was confirmed by a Health Care Coverage Determination Notice dated April 7, 2022, approving Petitioner for ongoing MA benefits since 2021. Exhibit B, (pp. 1-3).

¹ During the hearing, Petitioner gave verbal authorization for representation.

² The evidence suggested that MDHHS also closed the MA case of Petitioner's spouse and children.

Though it took MDHHS several months, the evidence established that MDHHS favorably resolved Petitioner's dispute over MA eligibility. With no unresolved dispute, Petitioner's hearing request is properly **DISMISSED**.
