### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on April 14, 2022. The Petitioner appeared and represented himself. Petitioner's daughter, ██████████ ██████████ appeared as a witness on his behalf. The Department of Health and Human Services (MDHHS) was represented by Tamaka Harris, Assistant Payments Supervisor.

### **ISSUE**

Did MDHHS properly cancel Petitioner's State Supplemental Security Income Payments (SSP)?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner received Supplemental Security Income (SSI) until ██████████ 2022.
2. On ██████████ 2022, MDHHS issued a Notice of State SSI Payment change informing Petitioner that his quarterly SSP is cancelled because the Social Security Administration (SSA) informed MDHHS that Petitioner is no longer receiving SSI (Exhibit A, pp. 6-7). SSI was suspended for Petitioner because SSA states that Petitioner has an unknown address.
3. On March 8, 2022, MDHHS received a timely submitted hearing request from Petitioner disputing MDHHS' cancellation of his SSP (Exhibit A, pp. 3-4).
4. On March 14, 2022, MDHHS issued Petitioner his last SSP since he was no longer receiving SSI.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

In this case, Petitioner requested a hearing regarding the cancellation of his SSP.


SSI is a cash benefit to needy persons who are aged (at least 65), blind or disabled. It is a federal program administered by the SSA. States are allowed the option to supplement the federal benefit with state funds. In Michigan, SSI recipients are eligible for an additional amount paid with state funds. MDHHS issues this SSP to SSI recipients. Payments are made for only those months the recipient received a regular first of the month federal benefit. BEM 660 (October 2020), pp. 1-2.

In this case, Petitioner's SSI was cancelled effective [REDACTED] 2022 due to the SSA stating that Petitioner is at an unknown address. At the hearing, MDHHS confirmed that as of the hearing date, the SSA still lists Petitioner's status as "S06", meaning suspended due to unknown address. Petitioner testified that he has lived at the same address for many years and expressed great confusion at this suspension. Petitioner confirmed that he has not yet contacted SSA or filed an appeal of the suspension. MDHHS provided contact information for the SSA to Petitioner at the hearing. Once Petitioner was no longer a SSI recipient, he was not eligible to receive SSP. Petitioner was advised that MDHHS is unable to make determinations as to SSI eligibility since it is a federal benefit administered by the SSA. Since Petitioner is no longer receiving SSI, he is not eligible to receive SSP from the state of Michigan. Therefore, MDHHS properly stopped issuing SSP.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that MDHHS acted in accordance with Department policy when it stopped issuing SSP to Petitioner when his SSI ended.

**DECISION AND ORDER**

Accordingly, MDHHS' decision is **AFFIRMED**.
