HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on April 27, 2022, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Jennifer Braxmaier Recoupment Specialist. Department Exhibit 1, pp. 1-58 was received and admitted.

ISSUE

Did the Department properly determine that Petitioner received an overissuance of Food Assistance Program (FAP) benefits due to client error?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of FAP benefits.
2. Petitioner's husband received an increase in employment income from Staff Corporation that exceeded the simplified reporting threshold and Petitioner failed to report that increase in income to the Department.
3. On March 16, 2022, Notice of Overissuance was sent to Petitioner alleging that she received an overissuance of FAP benefits from December 1, 2020, through December 31, 2020, due to client error in the amount of \$[REDACTED].
4. On [REDACTED] [REDACTED] [REDACTED] Petitioner requested hearing disputing the determination of overissuance.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Overissuance Amount FIP, SDA, CDC and FAP

The amount of the overissuance is the benefit amount the group or provider actually received minus the amount the group was eligible to receive. BAM 715

In this case, Petitioner failed to report an increase in employment income of a household member [REDACTED] [REDACTED] from Staff Corporation and as a result received an overissuance of FAP benefits in the amount of \$[REDACTED] for the time period from December 1, 2020, through December 31, 2020. Petitioner argued at hearing that the Department has access to employment records and should have been aware of the household member's income. Petitioner is required to report changes in employment income of a household member that exceeds the simplified reporting threshold and she failed to do so and that resulted in an overissuance of FAP benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that Petitioner received an overissuance of FAP benefits from December 1, 2020, through December 31, 2020, due to client error.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
