HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on November 3, 2022, from Lansing, Michigan. Petitioner represented herself. The Department was represented by Amber Gibson.

<u>ISSUE</u>

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for the Food Assistance Program (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner is an ongoing Food Assistance Program (FAP) recipient as a household of one.
- 2. Petitioner receives monthly Retirement, Survivors, and Disability Insurance (RSDI) in the gross monthly amount of and Supplemental Security Income (SSI) in the gross monthly amount of and State Supplemental Security Income (SSP) in the gross monthly amount of
- 3. Petitioner is responsible for monthly housing expenses of \$154 and she is entitled to the standard \$559 heat and utility deduction.
- 4. On September 21, 2022, the Department notified Petitioner that she is eligible for a \$149 monthly allotment of Food Assistance Program (FAP) benefits. Exhibit A, p 4.

5. On September 26, 2022, the Department received Petitioner's request for a hearing protesting her monthly allotment of Food Assistance Program (FAP) benefits. Exhibit A, p 3.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) is funded under the federal Supplemental Nutrition Assistance Program (SNAP) established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 through 7 USC 2036a. It is implemented by the federal regulations contained in 7 CFR 273. The Department administers FAP pursuant to MCL 400.10 of the Social Welfare Act, MCL 400.1 *et seq*, and Mich Admin Code, R 400.3001 through 400.3011.

All earned and unearned income available is countable unless excluded by policy. Earned income means income received from another person or organization or from self-employment for duties for duties that were performed for compensation or profit. Unearned income means all income that is not earned income. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. Department of Human Services Bridges Eligibility Manual (BEM) 500 (April 1, 2022), pp 1-17.

Petitioner is an ongoing recipient of FAP benefits as a household of one. Petitioner receives a gross monthly income totaling \$875, which consists of her RSDI, SSI, and SSP benefits. Petitioner's SSP benefits are paid quarterly but are converted to a monthly income when determining her eligibility for FAP benefits. Petitioner's adjusted gross income of \$ was determined by reducing her totaling income by the \$177 standard deduction.

Petitioner is entitled to a \$364 excess shelter deduction, which was determined by reducing the total of her \$154 housing expenses and the standard \$559 heat and utility deduction by 50% of her adjusted gross income.

The heat and utility standard covers all heat and utility costs including cooling, except actual utility expenses. FAP groups that qualify for the heat and utility standard do not receive any other individual utility standards. A FAP group which has a heating expense or contributes to the heating expense separate from rent, mortgage or condominium/maintenance payments must use the heat and utility standard. Department of Human Services Bridges Eligibility Manual (BEM) 554 (October 1, 2022), pp 15-21.

Petitioner's net income of \$ was determined by reducing her adjusted gross income by the excess shelter deduction. Effective October 1, 2022, the level of benefits granted

to households eligible for FAP benefits is updated, but before that date, a household of one with a net income of \$ is entitled to a \$149 monthly allotment of FAP benefits. Department of Health and Human Services Reference Table Manual (RFT) 260 (October 1, 2021), p 5.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for the Food Assistance Program (FAP).

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
