ORDER OF DISMISSAL

Upon the request for a hearing by the Michigan Department of Health and Human Services (MDHHS), this matter is before the undersigned administrative law judge in accordance with MCL 400.9, 7 CFR 273.16, 42 CFR 431.230(b), and 45 CFR 235.110, and Mich Admin Code, R 400.3130 and R 400.3178. MDHHS requested a hearing on December 13, 2022, to establish that the above-named Respondent received an overissuance of Food Assistance Program (FAP) and State Emergency Relief benefits. MDHHS also requested a hearing to establish against Respondent a FAP-related disqualification period.

After due notice, a hearing was scheduled to be held via telephone conference line on August 16, 2023 at 8:30 a.m. Neither Respondent nor MDHHS participated despite being given at least 15 minutes from the scheduled hearing time to call. Because MDHHS requested a hearing and failed to participate, its hearing request is properly **DISMISSED**.
