HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on February 8, 2023, from Lansing, Michigan. Petitioner was represented by her mother **E** The Department was represented by Amber Gibson.

ISSUE

Did the Department of Health and Human Services (Department) properly close Petitioner's State Supplemental Security Income (SSP) payments?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On November 19, 2022, the Department notified Petitioner that her State SSI payment would be cancelled.
- 2. On December 19, 2022, the Department received Petitioner's request for a hearing protesting the cancellation of the State Supplemental Security Income (SSP) payment.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM). The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

Supplemental Security Income (SSI) is a cash benefit to needy persons who are aged (at least 65), blind or disabled. It is a federal program administered by the Social Security Administration (SSA). States are allowed the option to supplement the federal benefit with state funds. In Michigan SSI benefits include a basic federal benefit and an additional amount paid with state funds. The amount of the state benefit varies by living arrangement. Payments of SSP benefits are made for only those months the recipient received a regular first of the month federal benefit. Department of Health and Human Services Bridges Eligibility Manual (BEM) 660 (October 1, 2021), p 1.

Petitioner was an ongoing SSP recipient when the Department discovered that she was no longer receiving a regular SSI payment from the Social Security Administration. Since Petitioner was not longer receiving regular SSI payments from the federal government, she is no longer eligible for the state SSP payment. Therefore, the Department notified Petitioner that her SSP payment would be cancelled.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it cancelled Petitioner's State Supplemental Security Income (SSP) payments.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
