HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on January 31, 2023, from Lansing, Michigan. Petitioner represented herself. The Department was represented by Alicia Mills and Yvette Bishop-Turnbull.

ISSUE

Did the Department of Health and Human Services (Department) properly deny Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On ██████████ ██████████ 2022, the Department received Petitioner's application for Food Assistance Program (FAP) benefits. Exhibit A, pp 10-16.
2. On November 18, 2022, the Department requested that Petitioner provide verification of her earned income from employment, and verification of her ending employment by November 28, 2022. Exhibit A, pp 17-19.
3. On December 14, 2022, the Department notified Petitioner that she was not eligible for Food Assistance Program (FAP) benefits. Exhibit A, pp 20-24.
4. On January 4, 2023, the Department received Petitioner's request for a hearing protesting the denial of Food Assistance Program (FAP) benefits. Exhibit A, pp 3-4.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) is funded under the federal Supplemental Nutrition Assistance Program (SNAP) established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 through 7 USC 2036a. It is implemented by the federal regulations contained in 7 CFR 273. The Department administers FAP pursuant to MCL 400.10 of the Social Welfare Act, MCL 400.1 *et seq*, and Mich Admin Code, R 400.3001 through 400.3011.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (April 1, 2022), p 9.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (January 1, 2023), pp 1-10.

On [REDACTED] [REDACTED] 2022, the Department received Petitioner's application for FAP benefits. On November 18, 2022, the Department requested that Petitioner provide verification of the earned income from employment in the previous 30 days and verification of the employment she reported to be ending on her application. When Petitioner did not provide the information in a timely manner, the Department notified her that she was not eligible for FAP benefits.

Petitioner testified while attempting to provide the Department with the information necessary to determine her eligibility for benefits that her caseworker was rude and hung up on her telephone call.

However, a complaint as to alleged misconduct or mistreatment by a state employee shall not be considered through the administrative hearing process but shall be referred to the department personnel director. Mich Admin Code, R 792.11002.


The hearing record supports a finding that Petitioner failed to provide the Department with information necessary to accurately determine her eligibility for FAP benefits in a timely manner.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied Petitioner's November 15, 2022, application for Food Assistance Program (FAP) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
