**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on April 13, 2023. The Petitioner appeared and was represented by ██████████, Authorized Hearing Representative (AHR). The Department of Health and Human Services (MDHHS) was represented by Charles Walker, Assistant Payments Supervisor, and Corlette Brown, Hearings Facilitator.

**ISSUE**

Did MDHHS properly cancel Petitioner's State Supplemental Security Income Payments (SSP)?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of Supplemental Security Income (SSI).
2. The Social Security Administration (SSA) closed Petitioner's SSI benefits, effective February 1, 2023.
3. On February 27, 2023, MDHHS received a timely submitted hearing request from Petitioner disputing the cancellation of his SSP benefits (Exhibit A, pp. 3-4).

**CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference

Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM). The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

In this case, Petitioner requested a hearing regarding the cancellation of his SSP.

SSI is a cash benefit to needy persons who are aged (at least 65), blind or disabled. It is a federal program administered by the SSA. States are allowed the option to supplement the federal benefit with state funds. In Michigan SSI benefits include a basic federal benefit and an additional amount paid with state funds. MDHHS issues this SSP to SSI recipients. Payments are made for only those months the recipient received a regular first of the month federal benefit. BEM 660 (October 2021), pp. 1-2.

In this case, MDHHS cancelled Petitioner's SSP benefits. MDHHS did not provide the Notice of Case Action showing the effective date that Petitioner's SSP was cancelled. In reviewing the State Online Query (SOLQ) report, which derives information directly from SSA, Petitioner did receive SSI on January 1, 2023. Therefore, Petitioner would be eligible for SSP for January 2023. Petitioner did not receive SSI February 1, 2023. Therefore, Petitioner would not qualify for SSP for February 2023. Petitioner testified that he re-applied for SSI and was approved, effective March 2023. Since MDHHS did not provide information about the dates that Petitioner was eligible for SSP and when his SSP was cancelled, MDHHS failed to satisfy its burden that they acted in accordance with policy in cancelling Petitioner's SSP.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that MDHHS failed to satisfy its burden that it acted in accordance with Department policy when it stopped issuing SSP to Petitioner.

### **DECISION AND ORDER**


Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Issue SSP for January 2023 to Petitioner;
2. Reevaluate Petitioner's eligibility for SSP effective March 1, 2023;
3. If eligible, issue Petitioner SSP for any months he was eligible for SSP but did not receive from March 1, 2023 ongoing;

4. Notify Petitioner of its decision in writing.
