**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned administrative law judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference line on April 19, 2023. Petitioner appeared and was unrepresented. The Michigan Department of Health and Human Services (MDHHS) was represented by Saquoyah Reeves, supervisor, and Angelque Whidby, specialist.

**ISSUE**

The issue is whether MDHHS properly determined Petitioner's Medicaid (MA) eligibility.

**FINDINGS OF FACT**

The administrative law judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. At all relevant times, Petitioner was disabled, residing alone, a recipient of Medicare, not pregnant, and not a caretaker to minor children.
2. As of March 2023, Petitioner received gross monthly Retirement, Survivors and Disability Insurance (RSDI) of \$██████████.
3. As of March 2023, MDHHS credited Petitioner with a monthly insurance premium obligation of \$258.
4. As of March 2023, Petitioner was eligible for Medicaid subject to a monthly deductible of \$1,189.
5. On March 15, 2023, Petitioner requested a hearing to dispute Medicaid eligibility.

### **CONCLUSIONS OF LAW**

The MA program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. MDHHS administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k. MA policies are contained in the Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), and Reference Tables Manual (RFT).

Petitioner requested a hearing in March 2023 to dispute the amount of her ongoing MA deductible/spenddown. Exhibit A, pp. 3-7. MDHHS testified, as of Petitioner's hearing request month, Petitioner was eligible to receive MA, subject to a \$1,189 monthly deductible. For purposes of this decision, Petitioner's MA eligibility beginning April 2023, the month after requesting a hearing will be evaluated.

Medicaid is also known as MA. BEM 105 (January 2021) p. 1. The MA program includes several sub-programs or categories. *Id.* To receive MA under a Supplemental Security Income (SSI)-related category, the person must be aged (65 or older), blind, disabled, entitled to Medicare or formerly blind or disabled. *Id.* Medicaid eligibility for children under 19, parents or caretakers of children, pregnant or recently pregnant women, former foster children, MOMS, MICHild and Healthy Michigan Plan is based on Modified Adjusted Gross Income (MAGI) methodology. *Id.*

Persons may qualify under more than one MA category. *Id.*, p. 2. Federal law gives them the right to the most beneficial category. *Id.* The most beneficial category is the one that results in eligibility, the least amount of excess income or the lowest cost share. *Id.*

As of the disputed benefit month, Petitioner was disabled, not pregnant, a Medicare recipient, and not a caretaker to minor children. Given Petitioner's circumstances, she is ineligible for all MAGI-related categories. As a disabled and/or aged individual, Petitioner is potentially eligible for Medicaid under the SSI-related category of Aged/Disability-Care (AD-Care).

MA categories are also split into categories of Group 1 and Group 2. *Id.*, p. 1. For Group 1, a group's net income must be at or below a certain income level for eligibility. *Id.* AD-Care is a Group 1 category. BEM 163 outlines the procedures for determining income eligibility under AD-Care.

At all relevant times, Petitioner was without minor children and did not reside with a spouse. For unmarried individuals without minor children, Petitioner's MA group size is one. BEM 211 (July 2019) p. 8.

As of the disputed benefit month, Petitioner received gross monthly income of \$ [REDACTED] from RSDI. Exhibit A, p. 9. Generally, MDHHS counts the gross amount of RSDI in

determining Medicaid eligibility.<sup>1</sup> BEM 503 (April 2019), p. 28. Petitioner's monthly countable income is \$[REDACTED] for purposes of AD-Care eligibility.

MDHHS gives AD-Care budget credits for employment income, guardianship expenses, and/or conservator expenses. Cost of living adjustments (COLA) are applicable for the benefit months of January through March only. BEM 503 (January 2019) p. 29. Petitioner did not allege any relevant budget expenses or credits.

For SSI-Related MA categories, MDHHS is to apply the deductions allowed in BEM 541 for adults. BEM 163 (July 2017) p. 2. A \$20 disregard is given for unearned income. BEM 541 (January 2023) p. 3. Subtracting the \$20 disregard results in a net income of \$[REDACTED].

Net income for AD-Care cannot exceed 100% of the federal poverty level. BEM 163 (July 2017) p. 2. In 2023, the annual federal poverty level (FPL) for a 1-person group in Michigan is \$14,580.<sup>2</sup> Dividing the FPL by 12 results in a monthly income limit of \$1,215: the same income limit is found in policy.<sup>3</sup> RFT 242 (April 2023) p. 1. Petitioner's monthly countable income exceeds the AD-Care income limit. Thus, MDHHS properly determined Petitioner to be ineligible for MA under AD-Care.

Though Petitioner is ineligible for MA benefits under AD-Care or any other Group 1 MA category, Petitioner may still receive MA under a Group 2 category. For Group 2 categories, eligibility is possible even when net income exceeds the income limit for a Group 1 category; this is possible because incurred medical expenses are used when determining eligibility. *Id.* Group 2 categories are considered a limited MA benefit because a deductible is possible. *Id.* For aged/disabled persons, G2S is the applicable Group 2 MA category.

Clients with a deductible may receive Medicaid if sufficient allowable medical expenses are incurred.<sup>4</sup> BEM 545 (April 2018), p. 11. Each calendar month is a separate deductible period. *Id.* The fiscal group's monthly excess income is called the deductible amount. *Id.* Meeting a deductible means reporting and verifying allowable medical expenses that equal or exceed the deductible amount for the calendar month. *Id.*

Petitioner's gross countable RSDI of \$[REDACTED] is unchanged for G2S. The G2S budget allows a standard \$20 disregard for unearned income and various employment income disregards. The G2S budget also factors ongoing medical expenses (which are applied

<sup>1</sup> Exceptions to counting gross RSDI include the following: certain former SSI recipients (e.g., disabled-adult children, 503 individuals, and early widowers), retroactive RSDI benefits, Medicare premium refunds, fee deductions made by qualified organizations acting as payee, and "returned benefits" (see BAM 500). No exceptions were applicable to the present case.

toward a deductible), insurance premiums, and remedial services. MDHHS credited Petitioner with monthly medical expenses of \$258 (rounding to highest dollar).

A client's deductible is calculated by subtracting the protected income level (PIL) from the client's net income. A PIL is a standard allowance for non-medical need items such as shelter, food and incidental expenses. The PIL for Petitioner's shelter area and group size is \$375. RFT 240 (December 2013) p. 1.

Subtracting the PIL (\$375), insurance premiums (\$258), and \$20 disregard from Petitioner's countable income (\$██████) results in a monthly deductible of \$1,189. MDHHS calculated the same deductible for Petitioner. Exhibit A, p. 11. Given the evidence, MDHHS properly determined Petitioner's MA eligibility.

### **DECISION AND ORDER**

The administrative law judge, based upon the above findings of fact and conclusions of law, finds that MDHHS properly determined Petitioner's MA eligibility for April 2023. The actions of MDHHS are **AFFIRMED**.
