HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 8, 2023, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Recoupment Specialist Minnie Egbuonu. Department Exhibit 1, pp. 1-104 was received and admitted.

ISSUE

Did the Department properly determine that Petitioner received an overissuance of Food Assistance Program (FAP) benefits due to agency error?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner was a recipient of FAP benefits.
- 2. Petitioner reported short term disability income that was not budgeted in error.
- On June 1, 2023, Notice of Overissuance was sent to Petitioner alleging that she received an overissuance of FAP benefits from November 1, 2022, through May 31, 2023, in the amount of \$2,430 due to agency error. (Ex. 1, pp. 7-8)
- 4. On July 3, 2023, Petitioner requested hearing disputing the finding of overissuance.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Definition

All Programs

An **agency error** is caused by incorrect actions (including delayed or no action) by the Michigan Department of Health and Human Services (MDHHS) staff or department processes. Some examples are:

Available information was not used or was used incorrectly.

Policy was misapplied.

Action by local or central office staff was delayed.

Computer errors occurred.

Information was not shared between department divisions such as services staff.

Data exchange reports were not acted upon timely (Wage Match, New Hires, BENDEX, etc.).

If unable to identify the type of overissuance, record it as an agency error.

Agency Error Exceptions FIP, SDA, CDC and FAP

Agency error overissuances are not pursued if the estimated amount is less than \$250 per program. BAM 705 (October 2018)

In this case, Petitioner reported short term disability income that was reported but not budgeted in error. As a result, Petitioner received \$2,430, in FAP benefits from the time period from November 1, 2022, through May 31, 2023, due to agency error that can be recouped. Department policy requires that agency error overissuances be recouped if they are over \$250. BAM 705

Petitioner requested at hearing that the overissuance be reduced due to her difficult financially circumstances and because the error was not her fault. The undersigned administrative law judge has no authority to waive Petitioner's overissuance due to her difficult financial circumstances.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that Petitioner received an overissuance of FAP benefits in the amount of \$2,430 during the time period from November 1, 2022, and May 31, 2023, due to agency error.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
