HEARING DECISION

Following Petitioner’s request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on November 2, 2023, from Lansing, Michigan. Petitioner represented herself. The Department was represented by Andrea Edwards.

ISSUE

Did the Department of Health and Human Services (Department) properly close Petitioner’s Medical Assistance (MA)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On July █████ 2023, the Department initiated a routine review of Petitioner’s eligibility for Medical Assistance (MA) as a household of two after receiving her completed Renew Benefits form. Exhibit A, pp 7-9.
2. On August █████ 2023, Petitioner received a paycheck showing gross earned income of \$██████████ and on August █████ 2023, she received a paycheck showing gross earned income of \$██████████ Exhibit A, pp 15-16.
3. On August █████ 2023, the Department notified Petitioner that he was not eligible for Medical Assistance (MA) benefits effective October 1, 2023. Exhibit A, p 11.
4. On September 25, 2023, the Department received Petitioner’s request for a hearing protesting the closure of her Medical Assistance (MA) assistance. Exhibit A, pp 4-6.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396 through 42 USC 1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10 through 42 CFR 420.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.103 through MCL 400.112k of the Social Welfare Act, MCL 400.1 *et seq.*

The income limit to participate in the Healthy Michigan Plan (HMP) is 133% of the federal poverty level. Department of Health and Human Services Reference Table Manual (RFT) 246 (April 1, 2014), p 1.

On July [REDACTED] 2023, the Department initiated a routine review of Petitioner's eligibility for ongoing MA benefits under the Healthy Michigan Plan (HMP). Petitioner received gross earned income from employment totaling \$[REDACTED] in August of 2023. This income is 256% of the federal poverty level for a household of two and it exceeds the 133% income limit. On August 31, 2023, the Department notified Petitioner that she was not eligible for MA benefits based on her income.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Medical Assistance (MA) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
