HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 42 CFR 431.200 to 431.250; and 45 CFR 205.10. After due notice, telephone hearing was held on December 12, 2023, from Lansing, Michigan. Petitioner represented himself. Alyssa Monterusso and Verenie Davis represented the Department of Health and Human Services (Department).

ISSUE

Did the Department of Health and Human Services (Department) properly determine that Petitioner did not meet the disability standard for State Disability Assistance (SDA)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On July [REDACTED] 2023, Petitioner submitted an application for State Disability Assistance (SDA) benefits alleging disability. Exhibit A, p 6.
2. On October [REDACTED] 2023, the Department's Disability Determination Service (DDS) determined that Petitioner did not meet the disability standard for State Disability Assistance (SDA) because it determined that Petitioner is capable of other work despite his impairments. Exhibit A, pp 25-26.
3. On October [REDACTED] 2023, the Department sent Petitioner notice that it had denied the application for assistance. Exhibit A, p 322.
4. On October [REDACTED] 2023, the Department received Petitioner's hearing request, protesting the denial of disability benefits. Exhibit A, pp 3-5.

5. Petitioner applied for federal Supplemental Security Income (SSI) benefits at the Social Security Administration (SSA) and a final decision remains pending. Exhibit A, p 321.
6. Petitioner is a [REDACTED] year-old man as of the date he filed his application for cash assistance whose birth date is September [REDACTED] 1980.
7. Petitioner is [REDACTED] tall and weighs [REDACTED] pounds.
8. Petitioner testified that he attended school through the 7th grade.
9. Petitioner is able to read and write and does have basic math skills.
10. Petitioner was not engaged in substantial gainful activity at any time relevant to this matter.
11. Petitioner has past relevant work experience as a security guard where was required to sit in front of a video monitor.
12. Petitioner's disability claim is based on arthritis and back impairments, and bi-polar syndrome and depression.
13. Petitioner has been diagnosed with depression and anxiety. Exhibit A, p 97.
14. Petitioner has been diagnosed with bi-polar disorder. Exhibit A, p 125.
15. On January [REDACTED] 2022, Petitioner reported suicidal ideation in the context of financial stressors, the risk of becoming homeless, and chronic pain. Exhibit A, p 109.
16. The results of a Patient Health Questionnaire (PHQ) score revealed mild mental impairments on August [REDACTED] 2023. Exhibit A, p 264.
17. Petitioner was found to have motor strength rated at 4/5 on August [REDACTED] 2023. Exhibit A, p 264.
18. Petitioner was found to have an unsteady gait and using a walker secondary to his chronic pain. Exhibit A, p 181.
19. Petitioner has a normal body mass index. Exhibit A, p 201.
20. Petitioner has been diagnosed with intervertebral disc degeneration. Exhibit A, p 289.

CONCLUSIONS OF LAW

The regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code, Rule 400.901 - 400.951. An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance has been denied. Mich Admin Code, R 400.903. Clients have the right to contest a Department decision affecting eligibility or benefit levels whenever it is believed that the decision is incorrect. The Department will provide an administrative hearing to review the decision and determine the appropriateness of that decision. Department of Health and Human Services Bridges Administrative Manual (BAM) 600 (January 1, 2020), pp 1-44.

The State Disability Assistance (SDA) program is established by the Social Welfare Act, MCL 400.1-.119b. The Department of Health and Human Services (formerly known as the Department of Human Services) administers the SDA program pursuant to 42 CFR 435, MCL 400.10 and Mich Admin Code, R 400.3151-.3180.

Pursuant to Federal Rule 42 CFR 435.540, the Department uses the federal Supplemental Security Income (SSI) policy in determining eligibility for disability under the Medical Assistance and State Disability Assistance (SDA) programs. Under SSI, disability is defined as:

...inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death, or which has lasted or can be expected to last for a continuous period of not less than 12 months. 20 CFR 416.905.

An individual is disabled for the purposes of establishing eligibility for SDA benefits when the individual meets federal SSI disability standards, except that the minimum duration of the disability shall be 90 days. 2022 PA 166, Sec. 604.

When determining disability, the federal regulations require that several considerations be analyzed in sequential order.

STEP 1

Does the client perform Substantial Gainful Activity (SGA)? If yes, the client is not disabled.

At step 1, a determination is made on whether Petitioner is engaging in substantial gainful activity (20 CFR 404.1520(b) and 416.920(b)). Substantial gainful activity (SGA) is defined as work activity that is both substantial and gainful. "Substantial work activity" is work activity that involves doing significant physical or mental activities (20 CFR 404.1572(a) and 416.972(a)). "Gainful work activity" is work that is usually done for pay or profit, whether or not a profit is realized (20 CFR 404.1572(b) and 416.972(b)). Generally, if an individual has earnings from employment or self-employment above a specific level set out in the regulations, it is presumed that he has demonstrated the ability to engage in SGA (20 CFR 404.1574, 404.1575, 416.974, and 416.975). If an individual engages

in SGA, he is not disabled regardless of how severe his physical or mental impairments are and regardless of his age, education, and work experience. If the individual is not engaging in SGA, the analysis proceeds to the second step.

Petitioner testified that he has not been employed since 2021 and he is not currently engaged in substantial gainful activity, which was not disputed by the Department during the hearing. Therefore, this Administrative Law Judge finds that Petitioner is not engaged in substantial gainful activity and is not disqualified from receiving disability at Step 1.

STEP 2

Does the client have a severe impairment that has lasted or is expected to last 12 months or more or result in death? If no, the client is not disabled.

At step two, a determination is made whether Petitioner has a medically determinable impairment that is "severe" or a combination of impairments that is "severe." An impairment or combination of impairments is "severe" within the meaning of the regulations if it significantly limits an individual's ability to perform basic work activities. An impairment or combination of impairments is "not severe" when medical and other evidence establish only a slight abnormality or a combination of slight abnormalities that would have no more than a minimal effect on an individual's ability to work (20 CFR 404.1521 and 416.921). If Petitioner does not have a severe medically determinable impairment or combination of impairments, he is not disabled. If Petitioner has a severe impairment or combination of impairments, the analysis proceeds to the third step.

Petitioner has the burden of proof of establishing that he has a severely restrictive physical or mental impairment that has lasted or is expected to last for the duration of at least 3 months or result in death.

Petitioner was ■ years-old when he applied for cash assistance. He is ■ tall and weighs ■ pounds. Petitioner alleges disability due to arthritis, back impairments, bi-polar syndrome, and depression.

The objective medical evidence indicates the following:

Petitioner has been diagnosed with depression, anxiety, and bi-polar disorder. Petitioner has a history of suicidal ideation in the context of financial stressors, the risk of becoming homeless, and chronic pain. Petitioner is receiving treatment for his mental impairments and a treating physician found his impairments to be mild.

Petitioner has been diagnosed with intervertebral disc degeneration and he suffers from chronic pain. Petitioner's motor strength was rated at 4/5. Petitioner has an unsteady gait and uses a walker secondary to his chronic pain.

The evidence on the record indicates that Petitioner's was been diagnosed with anxiety, depression, and bi-polar disorder as well as intervertebral disc degeneration by treating

physicians, which have resulted in significant impairments to his ability to sustain work related tasks.

This Administrative Law Judge finds a physical impairment that has more than a de minimus effect on Petitioner's ability to perform work activities. Petitioner's impairments have lasted continuously or are expected to last for twelve months. Petitioner is not disqualified from receiving disability benefits at step 2 and the analysis will continue.

STEP 3

Does the impairment appear on a special listing of impairments or are the client's symptoms, signs, and laboratory findings at least equivalent in severity to the set of medical findings specified for the listed impairment? If no, the analysis continues to Step 4.

At step three, a determination is made whether Petitioner's impairment or combination of impairments is of a severity to meet or medically equal the criteria of an impairment listed in 20 CFR Part 404, Subpart P, Appendix 1 (20 CFR 404.1520(d), 404.1525, 404.1526, 416.920(d), 416.925, and 416.926). If Petitioner's impairment or combination of impairments is of a severity to meet or medically equal the criteria of a listing and meets the duration requirement (20 CFR 404.1509 and 416.909), Petitioner is disabled. If it does not, the analysis proceeds to the next step.

Petitioner's physical impairments do not meet the listing for spinal stenosis because the objective medical evidence does not demonstrate a documented need for a walker or bilateral canes. Petitioner uses a walker secondary to chronic pain, but the hearing record supports a finding that he is capable of independent ambulation with an unsteady gait.

Petitioner's impairment failed to meet the listing for depression, anxiety, or bipolar disorder because the objective medical evidence does not demonstrate marked limitations of his ability to interact with others, concentrate, or adapt himself. The objective medical evidence indicates also does not establish that he required medical treatment in a highly structured setting or minimal capacity to adapt to changes in his environment.

The medical evidence of Petitioner's condition does not give rise to a finding that he would meet a statutory listing in federal code of regulations 20 CFR Part 404, Subpart P, Appendix 1.

STEP 4

Can the client do the former work that he performed within the last 15 years? If yes, the client is not disabled.

Before considering step four of the sequential evaluation process, a determination is made of Petitioner's residual functional capacity (20 CFR 404.1520(e) and 416.920(c)). An individual's residual functional capacity is his ability to do physical and mental work activities on a sustained basis despite limitations from his impairments. In making this finding, the undersigned must consider all of Petitioner's impairments, including

impairments that are not severe (20 CFR 404.1520(e), 404.1545, 416.920(e), and 416.945; SSR 96-8p).

Next, a determination is made on whether Petitioner has the residual functional capacity to perform the requirements of his past relevant work (20 CFR 404.1520(f) and 416.920(f)). The term past relevant work means work performed (either as Petitioner actually performed it or as it is generally performed in the national economy) within the last 15 years or 15 years prior to the date that disability must be established. In addition, the work must have lasted long enough for Petitioner to learn to do the job and have been SGA (20 CFR 404.1560(b), 404.1565, 416.960(b), and 416.965). If Petitioner has the residual functional capacity to do his past relevant work, Petitioner is not disabled. If Petitioner is unable to do any past relevant work or does not have any past relevant work, the analysis proceeds to the fifth and last step.

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium, and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor... 20 CFR 416.967.

Sedentary work. Sedentary work involves lifting no more than 10 pounds at a time and occasionally lifting or carrying articles like docket files, ledgers, and small tools. Although a sedentary job is defined as one which involves sitting, a certain amount of walking and standing is often necessary in carrying out job duties. Jobs are sedentary if walking and standing are required occasionally, and other sedentary criteria are met. 20 CFR 416.967(a).

Light work. Light work involves lifting no more than 20 pounds at a time with frequent lifting or carrying of objects weighing up to 10 pounds. Even though the weight lifted may be very little, a job is in this category when it requires a good deal of walking or standing, or when it involves sitting most of the time with some pushing and pulling of arm or leg controls.... 20 CFR 416.967(b).

To determine the skills required in the national economy of work you are able to do, occupations are classified as unskilled, semi-skilled, and skilled. These terms have the same meaning as defined in. 20 CFR 416.968.

Unskilled work. Unskilled work is work which needs little or no judgment to do simple duties that can be learned on the job in a short period of time. The job may or may not require considerable strength. For example, we consider jobs unskilled if the primary work duties are handling, feeding and offbearing (that is, placing or removing materials from machines which are automatic or operated by others), or machine tending, and a person can usually learn to do the job in 30 days, and little specific vocational preparation and judgment are needed. A person does not gain work skills by doing unskilled jobs. 20 CFR 416.968(a).

After careful consideration of the entire record, this Administrative Law Judge finds that Petitioner has the residual functional capacity to perform light work as defined in 20 CFR 404.1567 and 416.967.

Petitioner has relevant work experience as a security guard where he was required to observe video monitors. Petitioner's past work experience fits the description of sedentary and unskilled work.

There is no evidence upon which this Administrative Law Judge could base a finding that Petitioner is unable to perform work substantially similar to work performed in the past.

STEP 5

At Step 5, the burden of proof shifts to the Department to establish that Petitioner has the Residual Functional Capacity (RFC) for Substantial Gainful Activity.

Does the client have the Residual Functional Capacity (RFC) to perform other work according to the guidelines set forth at 20 CFR 404, Subpart P, Appendix 2, Sections 200.00-204.00? If yes, client is not disabled.

At the last step of the sequential evaluation process (20 CFR 404.1520(g) and 416.920(g)), a determination is made whether Petitioner is able to do any other work considering his residual functional capacity, age, education, and work experience. If Petitioner is able to do other work, he is not disabled. If Petitioner is not able to do other work and meets the duration requirement, he is disabled.

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements, and other functions will be evaluated.... 20 CFR 416.945(a).

The objective medical evidence indicates that Petitioner has the residual functional capacity to perform some other less strenuous tasks than in his prior employment and that he is physically able to do less strenuous tasks if demanded of him. Petitioner's testimony as to his limitations indicates that he should be able to perform light work.

Petitioner was able to answer the questions at the hearing and was responsive to the questions. Petitioner was oriented to time, person, and place during the hearing.

Petitioner's complaints of pain, while profound and credible, are out of proportion to the objective medical evidence contained in the file as it relates to Petitioner's ability to perform work.

Medical vocational guidelines have been developed and can be found in 20 CFR, Subpart P, Appendix 2, Section 200.00. When the facts coincide with a particular guideline, the guideline directs a conclusion as to disability. 20 CFR 416.969.

Petitioner is ■ years-old, a younger person, under age 50, with a limited education, and a history of unskilled work. Based on the objective medical evidence of record Petitioner has the residual functional capacity to perform light work. State Disability Assistance (SDA) is denied using Vocational Rule 202.17 as a guideline.


The Department's Program Eligibility Manual contains the following policy statements and instructions for caseworkers regarding the State Disability Assistance program: to receive State Disability Assistance, a person must be disabled, caring for a disabled person or age 65 or older. Department of Human Services Bridges Eligibility Manual (BEM) 261 (April 1, 2017), pp 1-8. Because Petitioner does not meet the definition of disabled under a Medicaid program and because the evidence of record does not establish that Petitioner is unable to work for a period exceeding 90 days, Petitioner does not meet the disability criteria for State Disability Assistance benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds Petitioner not disabled for purposes of the State Disability Assistance (SDA) benefits.

DECISION AND ORDER

Accordingly, the Department's determination is AFFIRMED.
