# **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 19, 2023, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Colleen McKenna. Department Exhibit 1, pp. 1-19 was received and admitted.

## ISSUE

Did the Department properly close Petitioner's Food Assistance Program (FAP) case for failing to submit the semi-annual contact report?

## **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner was receiving FAP benefits.
- 2. On August 1, 2023, a semi-annual contact report was sent to Petitioner with an August 21, 2023, due date.
- 3. Petitioner misplaced the semi-annual contact report and submitted a Change Report and check stubs on August 24, 2023.
- 4. On September 10, 2023, Notice of FAP Closure was sent to Petitioner informing her that her FAP case was closing effective September 30, 2023.

5. On October 19, 2023, Petitioner requested hearing disputing the closure of FAP benefits.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

### FAP Only

Benefits stop at the end of the benefit period unless a redetermination is completed and a new benefit period is certified. If the client does not begin the redetermination process, allow the benefit period to expire. The redetermination process begins when the client files a MDHHS-1171, Assistance Application and MDHHS1171-FAP, Supplement- Food Assistance Program; MDHHS-1010, Redetermination and MDHHS-1010-FAP; MDHHS-1171, filing form. BAM 210 (October 2023)

In this case, Petitioner was sent a semi-annual contact report on August 1, 2023, with an August 21, 2023, due date. Petitioner testified at hearing that she misplaced the semi-annual contact report. On September 10, 2023, Notice of FAP closure was sent to Petitioner informing her that her FAP case would be closing effective September 30, 2023. Petitioner submitted a change report and check stubs on September 25, 2023, by dropping them off at the local office. Petitioner testified that the front desk worker told her those documents were sufficient. Nothing in Petitioner's electronic case file reflects that she was advised that she did not need to submit her semi-annual contact report.

Petitioner was required to submit redetermination paperwork and she failed to do so. Therefore, the closure for failing to submit redetermination paperwork was proper and correct and consistent with Department policy. BAM 210

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's FAP case for failing to submit the semi-annual contact report.

## DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
