**ORDER OF DISMISSAL PURSUANT TO  
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner’s request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on January 16, 2024. [REDACTED] [REDACTED] Authorized Hearing Representative (AHR) represented Petitioner. The Department of Health and Human Services (Department) was represented by Tracy Nguyen, Assistance Payments Lead Worker.

The hearing was requested to dispute the Department’s action taken with respect to Food Assistance Program (FAP) and Child Development and Care (CDC) benefits. After commencement of the hearing, the Assistance Payments Lead Worker explained that FAP and CDC benefits have been reinstated for Petitioner’s case and Petitioner’s spouse verbally agreed to withdraw the hearing request. However, no written withdrawal was received. Petitioner’s AHR confirmed that there was no longer a contested issue for this administrative hearing. Petitioner’s AHR withdrew the hearing request on the record. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
