HEARING DECISION

On February 1, 2024, Petitioner, [REDACTED] [REDACTED] requested a hearing to dispute a Food Assistance Program (FAP) application denial. Following Petitioner's hearing request, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, 7 CFR 273.15, and Mich Admin Code, R 792.11002. After due notice, a Zoom hearing was held on March 13, 2024. Petitioner appeared and was self-represented. The Department of Health and Human Services (Department) was represented by Amber Gibson, Hearings Facilitator.

A 16-page packet of documents provided by the Department was admitted collectively as the Department's Exhibit A.

ISSUE

Did the Department properly determine Petitioner's application for FAP benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED] [REDACTED] 2024, Petitioner applied for FAP benefits.
2. Petitioner is a full-time student at [REDACTED] [REDACTED] [REDACTED]
3. The Department reviewed Petitioner's application for FAP benefits and determined that Petitioner is not an eligible student for FAP benefits because Petitioner was enrolled in college full-time but did not meet any of the additional criteria to be considered an eligible student.

4. On January 8, 2024, a Notice of Case Action was sent to Petitioner notifying Petitioner that Petitioner's application for FAP benefits was denied because Petitioner was an ineligible student.
5. On February 1, 2024, Petitioner requested a hearing to dispute the denial.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Petitioner is disputing the [REDACTED] 2024, FAP application denial due to ineligible student status.

A full-time student is ineligible for FAP benefits unless the student meets one of the following criteria: receiving Family Independence Program (FIP) assistance; enrolled as a result of a Job Training Partnership Act (JTPA) program; enrolled as a result of a program under Section 236 of the Trade Readjustment Act of 1974; enrolled in a FAE&T or FAE&T plus and either part of a career and technical education program as defined under the Perkins Strengthening Career and Technical Education Act and a course of study that will lead to employment or the student is limited to remedial courses, basic adult education, literacy, or English as a second language; participating in an employment and training program for low-income households operated by state and local government where one or more components of such program is at least equivalent to an acceptable FAP employment and training program component such as a program under the Carl D. Perkins Career and Technical Education Improvement Act of 2006; participating in another state or local government employment and training program; physically or mentally unfit for employment; employed for at least an average of 20 hours per week and paid for such employment; self-employed for at least an average of 20 hours per week and earning an average weekly income at least equivalent to the federal minimum wage multiplied by 20; participating in an on-the-job training program; participating in a state or federally funded work study program; providing more than half of the physical care of a group member under the age of six, or providing more than half of the physical care of a group member age six through eleven if the local office has determined that adequate child care is unavailable to enable the student to participate in work or work study. BEM 245 (July 1, 2023), pp. 4-6.


In this case, Petitioner is currently on a work study program wait list. Petitioner is unable to participate in the work study program because there are no open opportunities.

Petitioner must be participating in a state or federally funded work study program or meet one of the other criteria listed above to be considered an eligible student for FAP purposes. Here, no evidence was submitted by Petitioner to prove that the Department improperly determined that Petitioner is not an eligible student for FAP purposes.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with its policies and the applicable law when it denied Petitioner's [REDACTED] 2024, application for FAP benefits.

IT IS ORDERED, the Department's decision is **AFFIRMED**.
