**ORDER OF DISMISSAL PURSUANT TO
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on April 30, 2024. [REDACTED], son, represented the Petitioner. [REDACTED] [REDACTED] the Petitioner, was present. The Department of Health and Human Services (Department) was represented by Angela Drost, Assistance Payments Supervisor (APS).
