**ORDER OF DISMISSAL PURSUANT TO
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on May 15, 2024. [REDACTED] the Petitioner, appeared on his own behalf. [REDACTED] mother, appeared as a witness for Petitioner. The Department of Health and Human Services (Department) was represented by Davona Gilbert, Hearing Facilitator (HF).

The hearing was requested to dispute the Department's action taken with respect to Medical Assistance program (MA) benefits. After commencement of the hearing, the HF confirmed that Petitioner's MA benefits were reinstated due to the timely hearing request, Petitioner has reapplied for MA, and the Department is waiting for submission of the DHS-1004 Healthcare Coverage Supplemental Questionnaire. The Healthcare Coverage Supplemental Questionnaire is needed to redetermine Petitioner's eligibility for MA. The testimony of Petitioner's mother indicated Petitioner has also been determined to be a Disabled Adult Child (DAC) by the Social Security Administration (SSA). As discussed, the SSA DAC determination may also affect Petitioner's MA eligibility. Once a new eligibility determination is made, a written notice of the determination will be issued. Petitioner withdrew the hearing request on the record. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
