**ORDER OF DISMISSAL PURSUANT TO  
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner’s request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on May 16, 2024. [REDACTED] the Petitioner, appeared on her own behalf. The Department of Health and Human Services (Department) was represented by Brian Roedema, Assistance Payments Supervisor (APS).

The hearing was requested to dispute the Department’s March [REDACTED] 2024 action taken with respect to Food Assistance Program (FAP) benefits, which reduced the monthly benefit amount to \$[REDACTED] effective April 1, 2024. After commencement of the hearing, the APS confirmed that the Department has since re-determined Petitioner’s eligibility for FAP and found she was eligible for monthly benefits in the amount of \$[REDACTED] effective April 1, 2024. Accordingly, Petitioner indicated there was no longer a need to proceed with the hearing regarding the March [REDACTED] 2024 determination that reduced the monthly benefit amount to \$[REDACTED]. As discussed, Petitioner will pursue a hearing regarding the newer FAP eligibility determination. The hearing request was withdrawn on the record. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
