#### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on May 30, 2024, from Lansing, Michigan. Petitioner represented himself. The Department was represented by Rachel Meade.

## **ISSUE**

Did the Department of Health and Human Services (Department) properly close Petitioner's Medical Assistance (MA) benefits?

#### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner is an ongoing recipient of Medical Assistance (MA) and the caretaker of a minor child.
- 2. On April 2024, the Department notified Petitioner that his Medical Assistance (MA) benefits would be limited to the Plan First category.
- 3. On April 16, 2024, the Department received Petitioner's request for a hearing.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM). The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396 through 42 USC 1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10 through 42 CFR 420.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.103 through MCL 400.112k of the Social Welfare Act, MCL 400.1 *et seq.* 

Persons may qualify under more than one MA category. Federal law gives them the right to the most beneficial category. The most beneficial category is the one that results in eligibility or the least amount of excess income. Department of Health and Human Services Bridges Eligibility Manual (BEM) 105 (January 1, 2024), p 2.

Petitioner was an ongoing recipient of MA benefits under the Healthy Michigan Program (HMP), which provides health coverage to individuals with a modified adjusted gross income less than 133% of the federal poverty level. There is no asset test for HMP benefits. When the Department discovered that Petitioner's income exceeded the limit to receive HMP benefits, it notified him that he was eligible for only limited coverage under the Plan First category.

The Department does not dispute that Petitioner's eligibility for MA benefits as the caretaker of a minor child was not determined. As a caretaker of a minor child, Petitioner is potentially eligible for MA benefits, but there is an asset test for this category of MA.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it failed to determine the most beneficial category of Medical Assistance (MA) that Petitioner may be eligible for.

# **DECISION AND ORDER**

Accordingly, the Department's decision is REVERSED.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER: Initiate a determination of the Petitioner's eligibility for Medical Assistance (MA) under the most benefical category that he is eligible for effective April 1, 2024.
