**ORDER OF DISMISSAL PURSUANT TO
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on May 27, 2024. Laverne Duke, the Petitioner, appeared on her own behalf. The Department of Health and Human Services (Department) was represented by Verenie Daivs, Assistance Payments Supervisor (APS), and Nicole Smith, Eligibility Specialist (ES).

The hearing was requested to dispute the Department's March [REDACTED] 2024 action taken with respect to Food Assistance Program (FAP) benefits, which was a closure based on an alleged failure to provide check stubs. After commencement of the hearing, the Department confirmed that the Department has since re-instated Petitioner's FAP benefits because the New Hire Client Notice was received. Accordingly, Petitioner indicated there was no longer a need to proceed with the hearing regarding the March [REDACTED] 2024 closure determination. The May 10, 2024 hearing request regarding the FAP closure was withdrawn on the record. The Department agreed to the dismissal of the hearing request.

As discussed, Petitioner has a second hearing request filed to contest a more recent determination to reduce the amount of her FAP benefits effective May 1, 2024.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
