HEARING DECISION

On March 8, 2022, Petitioner, ██████████ ██████████, requested a hearing to dispute the Department's decision to cancel his State SSI Payment (SSP). Following Petitioner's hearing request, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on April 14, 2022. Petitioner appeared at the hearing and represented himself. Respondent, Department of Health and Human Services (Department), had Nakeisha Hilliker, Eligibility Specialist, appear as its representative. Neither party had any additional witnesses.

One exhibit was admitted into evidence during the hearing. An 11-page packet of documents provided by the Department was admitted collectively as the Department's Exhibit A.

ISSUE

Whether the Department properly cancelled Petitioner's SSP effective ██████████, 2022?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Social Security Administration (SSA) notified the Department that Petitioner did not receive a regular first of the month Supplemental Security Income (SSI) payment for January 2022 and February 2022.
2. On February 21, 2022, the Department updated Petitioner's case, and this caused the Department to cancel Petitioner's SSP effective ██████████ 2022.

3. On February 21, 2022, the Department mailed a notice of state SSI payment change to Petitioner to notify him that his SSP was going to be cancelled effective [REDACTED] 2022.
4. Effective [REDACTED] 2022, Petitioner is eligible for SSP again.
5. Petitioner requested a hearing to dispute the Department's decision.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

Supplement Security Income (SSI) is a cash benefit to needy persons who are aged (at least 65), blind, or disabled. BEM 660 (October 1, 2021), p. 1. SSI is administered by the Social Security Administration (SSA); the Department does not determine whether an individual is eligible for SSI. In Michigan, SSI payments are supplemented with State SSI Payments (SSP). *Id.* An individual is only eligible for SSP for the months an individual received a regular first of the month SSI payment as shown on the State On-Line Query (SOLQ). BEM 660 (October 1, 2021), p. 1. The SOLQ is an application that allows the Department to access SSA data.


In this case, Petitioner did not receive a regular first of the month SSI payment for January 2022 and February 2022. Thus, Petitioner was not eligible for SSP for January 2022 and February 2022. When the Department discovered that Petitioner stopped receiving SSI payments, the Department cancelled Petitioner's SSP. The Department's actions were in accordance with BEM 660.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did act in accordance with its policies and the applicable law when it cancelled Petitioner's State SSI Payments (SSP) effective [REDACTED] 2022.

IT IS ORDERED the Department's decision is **AFFIRMED**.
