HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION

The Michigan Department of Health and Human Services (MDHHS or the Department) requested a hearing alleging that Respondent Travis Hancock committed an intentional program violation (IPV). Pursuant to MDHHS' request and in accordance with MCL 400.9, 7 CFR 273.16, 42 CFR 431.230(b), and 45 CFR 235.110, and Mich Admin Code, R 400.3130 and R 400.3178, this matter is before the undersigned Administrative Law Judge. After due notice, a hearing was held via telephone conference on July 17, 2023. Joseph Gregurek, Regulation Agent of the Office of Inspector General (OIG), represented MDHHS. Respondent did not appear at the hearing, and it was held in Respondent's absence pursuant to 7 CFR 273.16(e)(4); Mich Admin Code, R 400.3130(5); or Mich Admin Code, R 400.3178(5).

ISSUES

1. Did MDHHS establish, by clear and convincing evidence, that Respondent committed an IPV concerning Food Assistance Program (FAP) benefits?
2. Should Respondent be disqualified from receiving FAP benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On February [REDACTED] 2020, Respondent submitted an application for FAP benefits, Medicaid (MA), and State Emergency Relief (SER). Prior to submission of the application, Respondent must review rights and responsibilities as a benefit recipient (Exhibit A, pp. 10-21).

2. On February [REDACTED] 2020, Respondent was interviewed by MDHHS as part of the application process. As part of the interview, rights and responsibilities are explained to Respondent by MDHHS (Exhibit A, pp. 22-24).
3. On February [REDACTED] 2020, MDHHS sent the Respondent a Notice of Case Action informing him that he was eligible for FAP benefits for a group size of three based upon \$0.00 earned income and reminding him of the obligation to report changes in household circumstances to MDHHS within ten days. A blank Change Report form was provided with the Notice of Case Action to facilitate the reporting of any future changes to MDHHS timely (Exhibit A, pp. 26-33).
4. On June 8, 2020, Respondent began employment at [REDACTED] [REDACTED] [REDACTED] [REDACTED] (Employer), receiving his first paycheck on June 16, 2020. Respondent's employment ended December 2, 2020 (Exhibit A, pp. 39-41).
5. From August 1, 2020 through November 30, 2020, Respondent received \$[REDACTED] in FAP benefits for a four-person FAP group (Exhibit A, p. 42).
6. Respondent does not have an apparent physical or mental impairment that would limit the understanding or ability to accurately report employment or household income.
7. Respondent has no prior FAP IPV disqualifications.
8. On February 13, 2023, MDHHS' OIG filed a hearing request alleging that Respondent intentionally failed to report earned income from employment and as a result received FAP benefits from August 1, 2020 through November 30, 2020 (fraud period) that Respondent was ineligible to receive. OIG requested that Respondent be disqualified from receiving FAP benefits for a period of 12 months due to committing an IPV. OIG stated that the FAP overissuance amount, which exceeded \$500, was previously established and is not at issue in this case.
9. A notice of hearing was mailed to Respondent at the last known address and was not returned by the United States Postal Services as undeliverable.

CONCLUSIONS OF LAW

MDHHS policies are contained in the MDHHS Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), Adult Services Manual (ASM), and Reference Tables Manual (RFT). The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is funded under the federal Supplemental Nutrition Assistance Program (SNAP) established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 7 USC 2036a. It is implemented by the federal regulations contained in 7 CFR 273. MDHHS administers FAP pursuant to MCL 400.10 of the Social Welfare Act, MCL 400.1 *et seq.*, and Mich Admin Code, R 400.3001 to R 400.3031.

Intentional Program Violation (IPV):

An IPV occurs when a recipient of MDHHS benefits intentionally made a false or misleading statement, or misrepresented, concealed, or withheld facts. 7 CFR 273.16(c)(1). Effective October 1, 2014, MDHHS's OIG requests IPV hearings for cases where (1) the total repayment amount sought from Respondent for all programs combined is \$500 or more or (2) the total repayment amount sought from Respondent for all programs combined is less than \$500 but the group has a previous IPV, the matter involves concurrent receipt of assistance, the IPV involves FAP trafficking, or the alleged fraud is committed by a state government employee. BAM 720 (October 2017), pp. 12-13.

To establish an IPV, MDHHS must present clear and convincing evidence that the household member committed, and intended to commit, the IPV. 7 CFR 273.16(e)(6); BAM 720, p. 1. Clear and convincing evidence is evidence sufficient to result in "a firm belief or conviction as to the truth of the precise facts in issue." *Smith v Anonymous Joint Enterprise*, 487 Mich 102, 114-115; 793 NW2d 533 (2010); see also M Civ JI 8.01. Evidence may be uncontroverted and yet not be clear and convincing; conversely, evidence may be clear and convincing despite the fact that it has been contradicted. *Smith* at 115. The clear and convincing standard is "the most demanding standard applied in civil cases." *In re Martin*, 450 Mich 204, 227; 538 NW2d 399 (1995). For an IPV based on inaccurate reporting, MDHHS policy also requires that the individual have been clearly and correctly instructed regarding the reporting responsibilities and have no apparent physical or mental impairment that limits the ability to understanding or fulfill these reporting responsibilities. BAM 720, p. 1.

In this case, MDHHS alleges that Respondent committed an IPV based on intentionally failing to report employment income with the intention to fraudulently maintain or prevent reduction in his FAP benefits. Earned income received by the client is considered in the calculation of a client's FAP eligibility and amount of benefits. BEM 500 (July 2020); BEM 556 (January 2020), pp. 2-3; 7 CFR 273.9(a). FAP recipients who are not simplified reporters are required to report starting or stopping employment and changes in circumstance that potentially affect eligibility or benefit amount within ten days of receiving the first payment reflecting the change. BAM 105 (July 2020), p. 12; 7 CFR 273.10(b)(1)(i). MDHHS then has ten days to process the change and, if it results in a decrease in benefits, it gives the client 12 days before the negative action impacts the benefits issued. BAM 220 (July 2020), p. 7, 12. Additionally, FAP recipients are expected to be truthful in all communications with MDHHS. BAM 105, p. 9.

Here, Respondent applied for FAP benefits on February [REDACTED] 2020. Prior to submitting the application, Respondent was required to review his rights and responsibilities as a benefit recipient, including reporting changes in employment and income. MDHHS issued a Notice of Case Action to Respondent on February [REDACTED] 2020, informing him that he was approved for FAP benefits based upon \$0.00 earned income and reminding him of his responsibilities to report changes to MDHHS within ten days. A blank Change Report form was provided with the Notice of Case Action to facilitate the reporting of any future changes to MDHHS timely. On June 8, 2020, Respondent began to work for Employer,

receiving his first paycheck on June 16, 2020. Respondent worked for Employer until December 2, 2020. Respondent did not report this employment to MDHHS. In their case presentation, MDHHS highlighted a Case Comment from August 5, 2020, in which Respondent called MDHHS to request a SER supplement and failed to report that he was employed (see Exhibit A, pp. 36-37). However, without direct testimony from the caseworker who spoke to Respondent in this conversation, it is difficult to place great weight on this comment and treat it as a failure to report with the intent to fraudulently maintain FAP benefits. While Respondent should have still reported this employment change and income, he did not misreport any information to MDHHS. Meaning, there was no written submission to MDHHS during the alleged fraud period in which Respondent failed to provide truthful information. A written misreporting of information is highly persuasive evidence of an intent to defraud consistent with an IPV. MDHHS did not present evidence of a written misreporting by Respondent. MDHHS also did not present evidence that they issued any correspondence to Respondent during the alleged fraud period. MDHHS has failed to establish that Respondent intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing, or preventing reduction of program benefits or eligibility once he began working for Employer. To find Respondent committed an IPV, the requisite intent that he failed to report in order to fraudulently obtain benefits must be clearly and convincingly proven by MDHHS. Here, Respondent may have purposely ignored his responsibility to report with the intent to defraud, but MDHHS failed to establish that by clear and convincing evidence. Thus, MDHHS did not establish an IPV by Respondent.

Therefore, MDHHS has **not** presented clear and convincing evidence that Respondent committed an IPV.

IPV Disqualification

An individual who is found pursuant to an IPV disqualification hearing to have committed a FAP IPV is disqualified from receiving benefits for the same program for 12 months for the first IPV, 24 months for the second IPV, and lifetime for the third IPV. 7 CFR 273.16(b)(1); BAM 720, p. 16. As discussed above, MDHHS has **not** established by clear and convincing evidence that Respondent committed an IPV. Therefore, Respondent is **not** subject to a period of disqualification from FAP.

Overissuance:

When a client group receives more benefits than entitled to receive, MDHHS must attempt to recoup the OI as a recipient claim. 7 CFR 273.18(a)(2); BAM 700 (October 2018), p. 1. The OI amount was previously established by MDHHS and not at issue in this case.

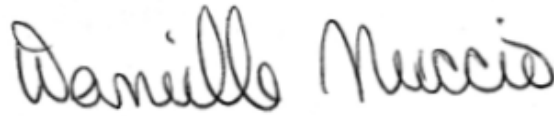
DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

1. MDHHS has not established by clear and convincing evidence that Respondent committed an IPV.

2. Respondent is not subject to a 12-month disqualification from FAP.

IT IS ORDERED that Respondent is not disqualified from FAP.
