HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 30, 2023. Petitioner (a minor child) was represented by his father, [REDACTED]. The Department of Health and Human Services (MDHHS) was represented by Ally Haught, Assistant Payments Supervisor, and Katherine Alzamora, Assistant Payments Worker.

ISSUE

Did MDHHS properly cancel Petitioner's State Supplemental Security Income Payments (SSP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is a recipient of Supplemental Security Income (SSI). In 2023, Petitioner has consistently received a monthly SSI payment.
2. On May 20, 2023, MDHHS issued a Notice of State SSI Payment change informing Petitioner that his quarterly SSP is cancelled because the Social Security Administration (SSA) informed MDHHS that Petitioner did not receive a regular first of the month SSI payment for 3 months and therefore is no longer eligible to receive SSP (Exhibit A, pp. 6-7).
3. On June 7, 2023, MDHHS received a timely submitted hearing request from Petitioner disputing the cancellation of his SSP benefits (Exhibit A, pp. 4-5).

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM). The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

In this case, Petitioner requested a hearing regarding the cancellation of his SSP.

SSI is a cash benefit to needy persons who are aged (at least 65), blind or disabled. It is a federal program administered by the SSA. States are allowed the option to supplement the federal benefit with state funds. In Michigan SSI benefits include a basic federal benefit and an additional amount paid with state funds. MDHHS issues this SSP to SSI recipients. Payments are made for only those months the recipient received a regular first of the month federal benefit. BEM 660 (October 2021), pp. 1-2.

In this case, MDHHS cancelled Petitioner's SSP benefits, stating that he did not receive regular first of the month SSI payments for 3 months. MDHHS testified that Petitioner received his SSI payment on July 2, 2023. MDHHS testified that they were unable to determine whether Petitioner received SSI on May 1 or June 1, but that Petitioner was issued SSI payments those months. AHR testified that Petitioner has always received SSI on the first day of each month in 2023. MDHHS did not present any evidence that Petitioner did not receive SSI on the first of each month and was not qualified to receive SSP. Therefore, MDHHS failed to satisfy its burden that they acted in accordance with policy in cancelling Petitioner's SSP.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that MDHHS failed to satisfy its burden that it acted in accordance with Department policy when it stopped issuing SSP to Petitioner.

DECISION AND ORDER

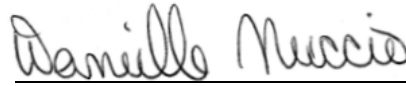
Accordingly, MDHHS' decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reevaluate Petitioner's SSP case as of May 20, 2023;
2. If Petitioner is eligible for SSP benefits, issue supplements to Petitioner for any SSP benefits he was eligible to receive but did not from May 20, 2023 ongoing;

3. Notify Petitioner of its decision in writing.
