HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on October 18, 2023, from Lansing, Michigan. Petitioner represented herself. The Department was represented by Rachel Meade.

ISSUE

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for Medical Assistance (MA) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing recipient of Medical Assistance (MA) benefits on July [REDACTED] 2023, when the Department received her Redetermination form. Exhibit A, p 6.
2. Petitioner reported on her July [REDACTED] 2023, Redetermination form that she was a household of one and that she was employed.
3. On August [REDACTED] 2023, Petitioner received a paycheck covering the pay period July 30, 2023, through August 12, 2023, with gross income of \$[REDACTED] Exhibit A, p 5.
4. The Department notified Petitioner that she was not eligible for Medical Assistance (MA) benefits. Exhibit A, p 15.
5. On September 5, 2023, the Department received Petitioner's request for a hearing protesting the closure of her Medical Assistance (MA) benefits. Exhibit A, p 4.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396 through 42 USC 1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10 through 42 CFR 420.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.103 through MCL 400.112k of the Social Welfare Act, MCL 400.1 *et seq.*

The income limit to participate in the Healthy Michigan Plan (HMP) is 133% of the federal poverty level. Department of Health and Human Services Reference Table Manual (RFT) 246 (April 1, 2014), p 1.

MA eligibility is determined on a calendar month basis. Unless policy specifies otherwise, circumstances that existed, or are expected to exist, during the calendar month being tested are used to determine eligibility for that month. When determining eligibility for a future month, assume circumstances as of the processing date will continue unchanged unless you have information that indicates otherwise. Department of Human Services Bridges Eligibility Manual (BEM) 105 (October 1, 2023), p 2.

Department policy is consistent with federal regulations under 42 CFR § 435.603(h) that state:

Financial eligibility for Medicaid for applicants, and other individuals not receiving Medicaid benefits at the point at which eligibility for Medicaid is being determined, must be based on current monthly household income and family size.

Petitioner was an ongoing recipient of MA benefits when the Department initiated a routine review of her eligibility for ongoing benefits. On August [REDACTED] 2023, Petitioner received gross earned income of \$[REDACTED] and Petitioner did not dispute receiving his paycheck. The income verified by Petitioner is the equivalent of 142% of the federal poverty level, and the limit to remain eligible for MA benefits is 133% of the federal poverty level.

Petitioner argued that her income varies, but failed to offer evidence that her current income fits the criteria to remain eligible for benefits. Petitioner has the burden of establishing that she is eligible for ongoing MA benefits, and as her circumstances change, her eligibility for MA benefits will also change.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for Medical Assistance (MA) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
