**HEARING DECISION**

Following Petitioner’s request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on November 9, 2023, from Lansing, Michigan. Petitioner was represented by his authorized hearing representative ██████ ██████. The Department was represented by Alley Haught and Dana Patch.

**ISSUE**

Did the Department of Health and Human Services (Department) properly determine Petitioner’s eligibility for Medical Assistance (MA) assistance?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing recipient of Medical Assistance (MA) on July █ 2023, then the Department sent him a Long-Term Care Medicaid Redetermination Notice with a due date of August 1, 2023.
2. On September █ 2023, the Department notified Petitioner that he was not eligible for Medical Assistance (MA) as of October 1, 2023.
3. On September 29, 2023, the Department received Petitioner’s request for a hearing.

## CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396 through 42 USC 1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10 through 42 CFR 420.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.103 through MCL 400.112k of the Social Welfare Act, MCL 400.1 *et seq.*

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (October 1, 2023), p 9.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (October 1, 2023), pp 1-10.

Petitioner was an ongoing recipient of MA benefits receiving Long Term Care (LTC) when the Department initiated a routine review of his eligibility for ongoing benefits by sending him a Long-Term Care Medicaid Redetermination Notice with the expectations that it be completed and returned by August 1, 2023. When that form was not received in a timely manner, the Department notified Petitioner that his MA benefits would close effective October 1, 2023.

The Department's representative testified that since receiving Petitioner's request for a hearing, additional information has been received from Petitioner's representative. Petitioner has been granted an extension to establish his eligibility for ongoing MA benefits, assuming that he continues to meet the eligibility criteria.


However, since Petitioner did not complete his Redetermination in a timely manner, the Department was acting in accordance with policy when it sent notification on September [REDACTED] 2023, that MA benefits would close.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it notified Petitioner that his Medical Assistance (MA) benefits would close effective October 1, 2023, for failing to return his redetermination forms.

**DECISION AND ORDER**

Accordingly, the Department's decision is AFFIRMED.
