ORDER DENYING REQUEST TO VACATE ORDER OF DISMISSAL

On March 7, 2023, the Michigan Office of Administrative Hearings and Rules (MOAHR) received Petitioner's request to vacate the Order of Dismissal issued by MOAHR on January 31, 2023, after Petitioner failed to participate in a hearing in the above-captioned matter scheduled for January 31, 2023. Petitioner stated in her request to vacate that she is requesting another hearing in this matter because she never knew the hearing was rescheduled for January 31, 2023.

A hearing in this matter was initially scheduled for January 12, 2023. The hearing was adjourned, and an Order of Adjournment, rescheduling the hearing for January 17, 2023, was mailed to Petitioner's address of record on January 12, 2023. On January 17, 2023, MOAHR received Petitioner's request for an adjournment of the January 17, 2023, hearing. On January 17, 2023, an Order Granting Adjournment for good cause was mailed to Petitioner's address of record. The Order Granting Adjournment advised Petitioner that the hearing was rescheduled for Tuesday, January 31, 2023, at 9:00 a.m. and instructed Petitioner how to access the hearing to participate.

Petitioner failed to establish good cause for her failure to participate in the January 31, 2023, hearing. The Order Granting Adjournment was mailed to Petitioner's correct address of record and not returned to MOAHR as undeliverable.

NOW, THEREFORE, IT IS ORDERED that the request to vacate the Order of Dismissal is **DENIED**.
